

## ORDER OF THE

BOARD OF VOCATIONAL, TECHNICAL AND ADULT EDUCATION

AMENDING, AND REPEALING AND CREATING
RULES RELATING TO DISTRICT BOARD
MEMBER APPOINTMENTS

The Wisconsin Board of Vocational, Technical and Adult Education proposes an order to amend ss. VTAE 2.04(1), (3)(intro.), (3)(b)4 and (4)(d); and to repeal and recreate ss. VTAE 2.06(1) and (2), relating to district board member appointments.

ANALYSIS PREPARED BY THE BOARD OF VOCATIONAL, TECHNICAL AND ADULT EDUCATION.

Statutory Authority: s. 38.04(15) and 227.11(2)(a), Stats. Statute Interpreted ss. 38.04(15) and 38.10(2)(c), Stats.

This proposed rule consists of an update of ch. VTAE 2, Wis. Admin. Code, which establishes procedures and standards for State Board review of appointments of members to vocational, technical and adult education district boards by local appointment committees. 1987 Wisconsin Act 94 enlarges the classifications of elected officials who can fulfill the elected official category on district boards; requires the State Board to review district board member appointments to determine whether they comply with the plan of representation adopted by the appointment committee and the category requirements under s. 38.08(1)(a),

Stats.; and provides for the State Board making appointments to district boards under certain circumstances.

Notwithstanding the fact that the Amendments contained in 1987 Wisconsin Act 94 apply to all appointments made on or after December 1, 1987, these amendments to ch. VTAE 2 apply to all appointments made on or after the first day of the month following publication of these rules

Following is a summary of the changes to ch. VTAE 2 proposed by this order:

- 1. Section VTAE 2.04(1) is amended to incorporate the requirement that all appointments reviewed by the State Board are required to meet the categorical enumeration under s. 38.08(1)(a), Stats. Additional technical changes are made to bring the rule into compliance with various technical modifications to terminology.
- 2. Section VTAE 2.04(3)(intro.) is amended to add a similar reference to the required categorical enumeration under s. 38.08(1)(a), Stats.
- 3. Section VTAE 2.04(3)(b)4 is amended to provide that a candidate shall disclose whether or not he or she is an elected official rather than an elected official of certain enumerated governmental units, since the enumeration is no longer set forth in the statutes.
- 4. Section VTAE 2.04(4)(d) is amended to provide that the categories of individuals eligible for appointment as elected official members are expanded to encompass all individuals who

hold state or local office as that term is defined under s. 5.02, Stats., except for those individuals who hold the office of party committeeman or party committeewoman.

- 5. Sections VTAE 2.06(1) and (2) are repealed and recreated to establish that the State Board is required to make district board appointments to district boards when the appointment committee cannot reach agreement; or when an appointment committee makes appointments following a prior disapproval of the appointments by the State Board and these new appointments are again determined to be in noncompliance with the plan of representation or s. 38.08(1)(a), Stats. Prior to 1987 Wisconsin Act 94 the State Board could only make the appointments if the appointment committee could not reach agreement.

5 ments that are resubmitted for board review under s. VTAE

6 2.04 and are again found by the board to be in noncompliance

8 (2) If the board is required to make appointments the

9 appointment committee shall forward to the board the most

10 recent approved plan of representation, the affidavit of each

11 applicant required under s. VTAE 2.04(3)(b), and, for

12 appointment matters arising under sub. (1)(a), a statement

13 explaining the reasons the appointment committee could not

14 reach agreement.

The rules, amendments and repeals contained in this order shall take effect on the first day of the month following publication as provided in s. 227.22(2)(intro.), Stats.
