SEC 9.01 Forms. (1) The following forms are prescribed for use under ch. 551, Stats., and may be obtained from the office of the commissioner of securities, Madison, Wisconsin:

(a) Securities registration application and reporting forms:

1. U-1. Uniform application to register securities.

2. U-2. Uniform consent to service of process.

3. RS-IC. Investment company report of sales.

4. RS-FC. Finance company report of sales.

(b) Licensing application and reporting forms:

1. BD. Uniform application for registration, license, or membership as a broker-dealer or to amend such application.

2. U-4. Uniform application for securities industry registration.

3. BDR(WI). Application for renewal of broker-dealer and agent license.

4. BDW(WI). Application for withdrawal from the status of a licensed broker-dealer.

5. U-5. Uniform termination notice for securities industry representative and/or agent.

6. ASIM(WI) Application for agent license to simultaneously represent more than one broker-dealer or issuer.

7. AIR. Application for renewal of an agent for issuer license.

8. IA. Wisconsin investment adviser license application.

9. IA RepA. Application for qualification as an investment adviser representative.

10. IAR(WI). Application for renewal of investment adviser license and qualification of adviser representatives.

11. IAW(WI). Application for withdrawal from the status of a licensed investment adviser.

12. IA Rep W. Application for withdrawal from the status of a qualified investment adviser representative.

13. CSP. Consent to service of process by broker-dealer or investment adviser.
