ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
AMENDING RULES

.
IN THE MATTER of amending s. NR 30.01(1)(h) .
of the Wisconsin Administrative Code . FR-48-88
pertaining to the establishment of an .
intensive fire protection zone. .
.

Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 26.11, 26.12 and 227.11(2)(a), Stats.
Statutes interpreted: s. 26.12, Stats.

The rule extends the intensive forest fire protection area in Jackson County to include the Town of Garfield. By such extension the Town of Garfield receives forest fire protection. Such protection will be provided by Department of Natural Resources personnel and equipment.

SECTION 1. NR 30.01(1)(h) amended to read:

NR 30.01(1)(h) Jackson county. All lands in: township 20 north, ranges 1 east, 1, 2, 3 and 4 west; township 21 north, ranges 1 east, 1, 2, 3 and 4 west; township 21 north, range 5 west except: section 18 - S 1/2 of the SW 1/4; section 19 - NW 1/4, N 1/2 of the SW 1/4, and SWSW; section 30 - W 1/2 of the NW 1/4; SE 1/4 of the NW 1/4; section 32 - S 1/2; township 22 north, ranges 1 east, 1, 2, 3 and 4 west; township 23 north, range 4 west; and township 24 north, range 5 and 6 west.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on December 15, 1988.

The rules shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
