ORDER OF THE STATE OF WISCONSIN
NATURAL RESOURCES BOARD
AMENDING RULES

21.015(1), 22.015(1) and 23.015 of the :
Wisconsin Administrative Code pertaining :
to changing the date of a free fishing :
day each year for sport fishing on all : FM-25-88
inland and outlying waters of the state. :

ANALYSIS PREPARED BY DEPARTMENT OF NATURAL RESOURCES

Statutory authority: ss. 29.155(1), 29.174(3), 227.11(2)(a) and
227.16(2)(e), Stats.
Statutes interpreted: ss. 29.155(1) and 29.174(1), Stats.

The proposed rules change the date of a free fishing day each year
for sport anglers fishing inland and outlying waters of the State to
coincide with National Fishing Week and to a Sunday rather than a
Saturday to provide a convenience to more anglers and their families.

SECTION 1. NR 20.0125(1) is amended to read:

NR 20.0125 LICENSE WAIVER. (1) On the third-Saturday first
Sunday of June each year, no fishing license is required to fish the
inland or outlying
waters.

SECTION 2. NR 21.015(1) is amended to read:

NR 21.015 LICENSE WAIVER. (1) On the third-Saturday first
Sunday of June each year, no license is required to fish the
Wisconsin-Minnesota boundary waters.

SECTION 3. NR 22.015(1) is amended to read:

NR 22.015 LICENSE WAIVER. (1) On the ~~third-Saturday~~ first Sunday in June each year, no fishing license is required to fish the Wisconsin-Iowa boundary waters.

SECTION 4. NR 23.015 is amended to read:

NR 23.015 LICENSE WAIVER. On the ~~third-Saturday~~ first Sunday in June each year, no fishing license is required to fish the Wisconsin-Michigan boundary waters.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on December 15, 1988.

The rules shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.


