Analysis Prepared by the Department of Natural Resources

Statutory authority: ss. 29.415 and 227.11(2)(a), Stats. Statutes interpreted: s. 29.415, Stats.

The Wisconsin endangered species law (s. 29.415, Stats.) requires periodic updating of our endangered and threatened species list. The most recent review resulted in the removal of Double-crested Cormorant from the threatened list in 1986. Since that time, the DNR Bureau of Endangered Resources have reviewed the status of 363 species on the Natural Heritage Inventory Working List. Subsequent status determinations are the result of consultation with species experts, field surveys, review of historical occurrences, and consideration of range-wide and global rarity of each species. Oral and written public comments were also taken into account. Factors considered to determine the biological status of each species include: rate of population decline or increase, reproductive success of existing population, threats to remaining populations, status throughout its range and status as a Wisconsin native species.

The Department is proposing the following changes to the endangered and species lists: 2 birds being moved from the endangered list to the threatened list, 3 plants being moved from the threatened list to the endangered list, 2 animals being removed from the threatened list, 28 animals and 1 plant being added to the endangered list, and 33 plants and animals being added to the threatened list.
