The Nursing Home Administrators Examining Board proposes an order to amend NHA 1.02(4) (a) and (b) and (6) (intro) and to create 1.02(6)(e) relating to definitions.

ANALYSIS

Statutory authority: ss. 15.08(5)(b), 227.11(2)(a), 456.02, Stats. Statute interpreted: s. 456.02, Stats.

In this order the Nursing Home Administrators Examining Board amends subchapter 1.02(4) and NHA 1.02(6) relating to definitions. The board seeks to change the phrase "long-term care facilities" to "licensed nursing homes." The board also creates NHA 1.02(6)(e) adding to the definition of "Experience in the field of institutional administration," the exposure to and knowledge of state and federal inspections for compliance with applicable nursing home laws and regulations.

TEXT OF RULE

<u>ORDER</u>

Pursuant to authority vested in the Nursing Home Administrators Examining Board in ss. 15.08(5)(b), 227.11(2)(a) and 456.02, Stats., the Nursing Home Administrators Examining Board hereby amends NHA 1.02 (4) (a) and (b) and (6) (intro) and creates 1.02 (6) (e) relating to definitions.

SECTION 1. NHA 1.02(4) (a) and (b) and (6) (intro) are amended to read:

NHA 1.02 (4) (a) Laws governing the operation of long-term-care-facilities <u>licensed nursing homes</u>;

(b) Elements of proper and effective administration of long-term-care-facilities <u>licensed nursing homes</u>;

Protection of the interests, safety and well-being of residents; and

Psychological, physical, medical and social needs of residents.

(6) (intro) "Experience in the field of institutional administration" means work experience acquired as an employe, student, trainee or intern in the total operation and activities of a regulated-health-eare-facility, licensed nursing home under the supervision of persons licensed under ch. 456, Stats., and exposure to and knowledge of the following:

SECTION 2. NHA 1.02(6)(e) is created to read:

NHA 1.02(6)(e) State and federal inspections for compliance with applicable nursing home laws, rules and regulations.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22(2)(intro), Stats.
