ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
AMENDING, AND REPEALING AND RECREATING RULES

.....
IN THE MATTER OF amending s. NR 8.04(2); and .
repealing and recreating s. NR 8.04(1)(c) of .
the Wisconsin Administrative Code pertaining . LE-25-89
to identification cards .

Analysis Prepared by Department of Natural Resources

Statutory authority: s. 227.11(2), Stats.

Statutes interpreted: s. 29.09(1), Stats.

This rule will eliminate the requirement that the Department issue sportsperson identification cards. Existing cards remain acceptable proof for residency purposes when purchasing a resident hunting, fishing or trapping license.

SECTION 1. NR 8.04(1)(c) is repealed and recreated to read:

NR 8.04(1)(c) Sportsperson identification card. A valid sportsperson identification card issued prior to the effective date of this rule ...[revisor insert date] may be used to obtain licenses listed in s. NR 8.04(intro.). The sportsperson identification card shall be valid for an indefinite period of time.

SECTION 2. NR 8.04(2) is amended to read:

NR 8.04(2) PERSONS WITHOUT IDENTIFICATION. All Wisconsin residents 18 years of age and older without identification listed in sub. (1) shall fill out and sign the declaration of residency form provided by the department. Issuing agents shall issue the license immediately on the basis of the declaration of residency form. The declaration of residency shall contain the following information: complete name, address, former last name if applicable, date of birth, place of birth, physical description, county of residence, date applicant established Wisconsin residency, current phone number, current or latest employer, student or military status if applicable, property ownership in Wisconsin if applicable, and signature.

Any person who ~~makes a false statement~~ provides incorrect information on the declaration of residency form and thereby obtains any license shall be subject to prosecution under s. 29.642, Stats.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on April 27, 1989.

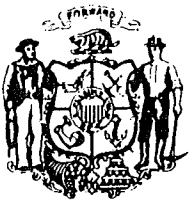
The rules shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.


