





NR 15.01 Year round game refuge. A game refuge is created in the following areas as posted with department signs and no person may hunt or trap upon such areas or have in possession or under control any gun or rifle unless the same are unloaded and enclosed within a carrying case, or any bow unless it is unstrung or enclosed within a carrying case.


(1) BROWN COUNTY. (a) *Bay Beach*. Township 24 north, range 21 east, city of Green Bay.




NR 15.021 No entry game refuge (Nov. 15 - Dec. 31). A game refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time or enter such areas from November 15 through December 31.


NR 15.022 No entry game refuge (Oct. 1 - Nov. 30); gun deer hunting permitted. A game refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time, or enter such areas for any reason from October 1 through November 30 except to hunt deer during the open season for hunting deer established in s. NR 10.01 (3) (e), trapping by permit in the area described in sub. (5), and except for the retrieval of legally killed or crippled game in posted retrieval zones.


(b) *Townline reservoir*. Township 26 north, range 6 east, town of Bergen.





(2) RACINE COUNTY. (a) *Dover*. Township 3 north, range 20 east, town of Dover.




(b) *Tichigan wildlife area*. Township 4 north, range 19 east, town of Waterford.


