Order of the State Fair Park Board

An order to repeal and recreate SFP 3.01(3)(c), relating to the regulation of parking.

Analysis prepared by the State Fair Park Board.

Statutory Authority: 93.24 (1)(c), Stats. SFP 3.01 (3)(c) repeals and recreates the existing SFP 3.01 (3)(c). The new rule expands on the existing regulation with greater detail regarding parking regulations at State Fair Park (SFP). The new rule establishes a set of parking restrictions which will be processed under the Wisconsin Administrative Code rather than the Wisconsin This enables SFP to set more appropriate fines and to Statutes. retain the revenue derived from such fines. In addition, it is estimated that the fine levels will decrease the number of contested citations and therefore require fewer court appearances by SFP law enforcement personnel.

Text of the rule.

SECTION 1. SFP 3.01 (3)(c) is repealed and recreated to read:

1. No person may park a vehicle in the park for more than 24 continuous hours unless a permit has been issued by the police department.

2. No person may stop or leave any vehicle in any of the following places except temporarily while loading or unloading or receiving or discharging passengers and while the vehicle is attended by a licensed operator so that it may promptly be moved in case of an emergency or to avoid obstruction of traffic:

- a. In a loading zone;
- b. In an alley or driveway;
- c. Within 10 feet of a fire hydrant or in a fire zone;
- d. Within 4 feet of the entrance to an alley, a private road or driveway;
- e. Closer than 15 feet to the near limits of a crosswalk;
- f. Within an intersection;
- g. On a sidewalk or sidewalk area;
- h. In an area reserved for parking for a physically disabled person, except for a motor vehicle used by a physically disabled person as defined under s. 346.503 (1), stats.; or
- i. Where and at the time when parking is prohibited, limited or restricted by an official traffic sign or marking.

3. Vehicles found in violation of parking statutes or regulations may be towed away. The operator or owner of a towed vehicle shall pay all charges for towing and storage and any applicable fines or forfeitures.

4. Traffic and parking may be temporarily restricted or prohibited by order of the director or the chief of police for reasons of maintenance, snow removal or other temporary conditions.

5. Persons violating subd. 1 shall be fined \$10. A \$5 fine shall be imposed for any violation of subd. 2 except that persons violating subd. 2. c and h shall be fined \$10 and \$25, respectively. In addition, late payment charges shall be imposed as follows: \$5 for payments that are at least 10 days late, \$10 for payments that are at least 30 days late and \$25 for payments that are at least 60 days late.

This rule shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2) (intro.), stats.
