ORDER OF THE STATE OF WISCONSIN
NATURAL RESOURCES BOARD
AMENDING AND CREATING RULES

Analysis Prepared by Department of Natural Resources

Statutory authority: s. 227.11(2)(a), Stats.

Statutes interpreted: ss. 147.035, 147.04, 147.06, and 147.07, Stats.

The Wisconsin Department of Natural Resources established the Wisconsin Pollutant Discharge Elimination System (WPDES) in 1976. Among other things, WPDES establishes new source performance standards (NSPS), pretreatment standards for existing sources (PSES), and pretreatment standards for new sources (PSNS) for various categories of industries which discharge wastewater to either waters of the state or publicly owned treatment works. Chapter NR 205, Wis. Adm. Code, sets forth the general provisions for WPDES.

The amendment to s. NR 205.03(31) corrects a cross-reference in the definition of "publicly owned treatment works."

Definitions for "NSPS", "PSES", and "PSNS" will be added as s. NR 205.04(40m), (43k), and (43n) to reduce the burden of using the complete terms when the chapters for each point source category are revised. These terms appear frequently in the chapters for the various point source categories. In recent consultation with the Legislative Council Rules Clearinghouse (LCRC) regarding the revision of chapters for various industrial categories, the LCRC recommended that these abbreviations be defined in s. NR 205.04 rather than in each chapter where the terms are used.

SECTION 1. NR 205.03(31) is amended to read:

NR 205.03(31) "Publicly owned treatment works" has the meaning specified under s. ~~NR 211.03(8)~~ 211.03(11).

SECTION 2. NR 205.04(40m), (43k) and (43n) are created to read:

NR 205.04(40m) "NSPS" means new source performance standards.

(43k) "PSES" means pretreatment standards for existing sources.

(43n) "PSNS" means pretreatment standards for new sources.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on October 26, 1989

The rules shall take effect the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22 (2)(intro.), Stats.


