ORDER

An order of the Medical Examining Board to create Med 10.02 (2) (w) of the administrative code relating to use of the term "board certified" or a similar like meaning in advertising.

Analysis prepared by the Department of Regulation and Licensing.

<u>ANALYSIS</u>

Statutes interpreted: s. 448.01 (11), Stats.

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) (a), 448.40, Stats.

In this order the Medical Examining Board is creating proposed rules relating to use of the term "board certified" in advertising because the practice has developed in numerous states of physicians using the term "board certified" in advertising but not stating the name of the board by which they are certified. The term "board certified" frequently appears in conjunction with a list of services that the physician provides. The general public could easily be misled into thinking that the physician was certified in all of those services whereas in fact the name of his actual certifying board was not listed in the ad. Other instances occurred in which the term "board certified" was used by physicians who are "certified" by the National Board of Medical Examiners. However, these physicians were not certified by any specialty board. A physician who identifies himself as a recognized specialist must have received such recognition from a specialty board of the American Board of Medical Specialties.

TEXT OF RULE

SECTION 1. Med 10.02 (2) (w) is created to read:

Med 10.02 (2) (w) Use in advertising of the term "board certified" or a similar phrase of like meaning unless in fact so certified and unless disclosure is made of the complete name of the specialty board which conferred the certification.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22 (2) (intro), Stats.
