Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 26.11, 26.12 and 227.11(2)(a), Stats.
Statutes interpreted: s. 26.12, Stats.

The rule extends the extensive forest fire protection area in Iowa county to include sections 7 and 8, T6N, R1E of the Town of Highland. By such extension all of the Town of Highland receives forest fire protection. Protection will be provided by Department of Natural Resources personnel and equipment.

SECTION 1. NR 30.02(1)(f) is amended to read:

NR 30.02(1)(f) Iowa county. All lands in: township 6 north, range 1 east, sections 1, 2, 3, 4, 5 and 6, 7 and 8; township 6 north, range 2 east, sections 1, 2, 3, 4, 5 and 6; township 6 north, range 3 east, sections 1, 2, 3, 4, 5 and 6; township 6 north, range 4 east, sections 1, 2, 3, 4, 5 and 6; township 6 north, range 5 east, sections 1, 2, 3, 4, 5 and 6; township 7 north, range 5 east, sections 1, 2, 3, 4, 5 and 6; township 7 north, ranges 1, 2, 3, 4 and 5 east; township 8 north, ranges 1, 2, 3, 4 and 5 east.

The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on February 28, 1991.

The rule shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.




