General Summary of Rule. This rule renumbers ch. Hy 36 and amends ss. Trans ?76.01 and 276.02, Wis. Admin. Code, relating to the weight limits for the steering axle of truck tractors. No substantive change is made in the rule.

Final Regulatory Flexibility Analysis. The provisions of this rule will have no direct adverse effect on small businesses.

Final Fiscal Impact. ### TEXT OF RULE

Under the authority vested in the Wisconsin department of transportation by s. 85.16(1), Stats., the department of transportation hereby repeals

ch. Hy 36 (title) and s. Hy 36.01, renumbers s. Hy 36.02, repeals and recreates ch. Trans 276 (title), and amends ss. Trans 276.01 and 276.02, Wisconsin Administrative Code, as follows:

SECTION 1. Chapter Hy 36 (title) and section Hy 36.01 are repealed.

SECTION 2. Section Hy 36.02 is renumbered as section Trans 276.10.

SECTION 3. Chapter Trans 276 (title) is repealed and recreated to read:

SIZE AND WEIGHT OF VEHICLES AND VEHICLE COMBINATIONS

SECTION 4. Section Trans 276.01(1) is amended to read:

Trans 276.01 GENERAL. (1) SCOPE. This chapter identifies and designates a list of qualifying highways for the operation of vehicles and combinations of vehicles the overall lengths of which cannot be limited. In addition, this chapter clarifies other statutory provisions or federal rules affecting the weight, width and length of vehicles and combination of vehicles and the number of vehicles in combination.

SECTION 5. Section Trans 276.02 is amended to read:

Trans 276.02 DEFINITIONS. In this chapter words and phrases have the meanings designated in s--340-01 chs. 340 and 348, Stats., and ch. Trans 250, unless a different meaning is expressly provided in this chapter.
