
(b) *Mud lake*. Township 11 north, range 10 east, town of Lowville.



(9) MARQUETTE COUNTY. (a) *Germania*. Township 17 north, range 10 east, town of Crystal Lake.






(d) Winona pool (Pool 5). Township 19 north, range 12 west, town of Buffalo.




(2) CRAWFORD COUNTY. (a) *Harpers slough (Pool 9)*. Township 9 north, range 6 west, town of Seneca.




(3) GRANT COUNTY. (a) *Dago slough (Pool 11)*. Township 2 north, range 4 west, town of Seneca.




