ORDER OF THE
STATE SUPERINTENDENT OF PUBLIC INSTRUCTION
AMENDING RULES

The state superintendent of public instruction hereby amends ch. PI 22, relating to criteria for the review and approval of applications for underrepresented minority group pupil precollege scholarships.

ANALYSIS BY THE DEPARTMENT OF PUBLIC INSTRUCTION

Statutory authority: ss. 115.43 (2) (c) and 227.11 (2) (a), Stats.

Statute interpreted: s. 115.43, Stats.

Section 115.43, Stats., requires the state superintendent to award precollege scholarships, on a competitive basis, to minority group pupils who enroll in college or university classes or programs designed to improve academic skills that are essential for success in postsecondary school education.

Currently, only vocational, technical and adult education institutions preparing pupils to attend a 4-year college are eligible to participate in this scholarship program. The proposed rule will make all vocational, technical and adult education institutions eligible to participate.

The state superintendent shall give preference in awarding the scholarships to minority group pupils who are inadequately represented in the university of Wisconsin system as well as the vocational, technical and adult education system.

1 SECTION 1. PI 22.02 (3) and (4) are amended to read:

2 PI 22.02(3) "Postsecondary educational institutions" means the university of Wisconsin

3 system campuses, private four-year colleges and universities in Wisconsin, and ~~the college~~

1 ~~parallel programs offered through~~ Wisconsin vocational, technical and adult education
2 institutions.

3 (4) "Precollege programs" means classes or programs designed by postsecondary
4 educational institutions to improve pupils' academic skills necessary for success in college
5 study and vocational, technical and adult education studies.

6 SECTION 2. PI 22.06(3) is amended to read:

7 PI 22.06(3) Preference in scholarship awards, including those for programs in private
8 colleges or colleges outside the university of Wisconsin system, shall be given to minority
9 group pupils who are inadequately represented in the university of Wisconsin ~~system~~
10 and vocational, technical and adult education systems.

The rules contained in this order shall take effect on the first day of the month commencing after the date of publication in the Wisconsin Administrative Register, as provided in s. 227.22 (2) (intro.), Stats.
