ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES REPEALING AND RECREATING AND CREATING RULES

To repeal and recreate HSS 152.06(Table) and to create HSS 152.02(15m) and 152.06(8), relating to reimbursement for treatment of chronic renal disease.

Analysis Prepared by the Department of Health and Social Services

Section 1536 of the current Budget Act, 1991 Wisconsin Act 39, amended s. 49.487, Stats., to require the Department to revise its kidney disease aid sliding scale of patient liability for part of the cost of treatment to ensure that the treatment needs of lower income patients receive priority within the funds available for this reimbursement program.

This order amends the sliding scale of patient liability for part of the cost of treatment by moderately increasing liability at the upper income levels. The order also provides for copayments by patients for prescription drugs and links that requirement to the Medical Assistance program's prescription copyament schedule, and defines Medical Assistance by reference to a statutory definition.

The Department's authority to repeal and recreate and create these rules is found in s. 49.48(2), Stats. The rules interpret s. 49.48, Stats., and s. 49.487, Stats., as amended by 1991 Wisconsin Act 39.

SECTION 1. HSS 152.02(15m) is created to read:

HSS 152.02(15m) "Medical assistance" has the meaning specified in s. 49.43(8), Stats.

SECTION 2. HSS 152.06(8) is created to read:

HSS 152.06(8) PATIENT COPAYMENT. If a pharmacy directly bills the chronic renal disease program for a prescription received by an ESRD patient, that patient is responsible for the same copayment amount a medical assistance recipient incurs for a similar prescription. However, the partial medical assistance copayment exemptions in s. 49.45(18), Stats., do not apply to an ESRD patient.
