#### ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD CREATING RULES

IN THE MATTER of creating s. NR 445.05(7)(c) of the . Wisconsin Administrative Code, pertaining to the . extension of compliance deadlines for chloroform . emissions for members of the pulp and paper . industry.

Authorizing statutes: ss. 144.31(1)(a), 144.375(5)(b), 144.38 and 227.11(2)(a), Stats.

Statutes interpreted: ss. 144.31(2)(a), 144.375(5)(b) and 144.38, Stats.

The hazardous air contaminant rule currently requires sources of chloroform emissions to control their emissions of chloroform to a level which is the best available control technology (BACT). The final compliance deadline for achieving the emission limit for chloroform is April 1, 1993 if compliance involves measures other than installation of control equipment, or April 1, 1994 if compliance requires installation of control equipment.

The rule revision authorizes the department to grant an extension to the final compliance deadline date for sources of chloroform in the pulp and paper industry provided the owner or operator of the source submits in writing a request for an extension at least 180 days before the source's final compliance deadline and demonstrates that reasonable progress is being made toward meeting the BACT requirements, good faith efforts have been made to comply with the final compliance deadline, all reasonably available alternatives for compliance have been evaluated and that compliance with the final deadlines is technologically infeasible, would cause substantial economic detriment to the source or would result in a significant problem associated with another inconsistent compliance deadline which applies to the source. Any request for an extension is subject to a public notice, 30-day public comment period and the opportunity for a public hearing.

SECTION 1. NR 445.05(7)(c) is created to read:

NR 445.05(7)(c) 1. An owner or operator of a source in the pulp and paper industry may obtain up to a 2 year extension of the compliance deadlines in sub. (6)(g)3 or par. (b)3 for chloroform emissions, if the owner or operator at least 180 days prior to the final compliance deadline in sub.
