ORDER ADOPTING RULE

Analysis Prepared by the Wisconsin Department of Transportation

STATUTORY AUTHORITY: s. 343.305, Stats. STATUTE INTERPRETED: s. 343.305, Stats.

General Summary of Rule. This rule is impacted by changes that occur in the fields of science and law as they relate to breath alcohol testing. The amendments to this rule will keep it current with changes in the science of breath testing, clarify responsibilities of the chief of the chemical test section and update the list of equipment approved for use in breath alcohol testing, approval and permit program.

<u>Fiscal Estimate</u>. The modification of the breath testing program as a result of this rule will not significantly increase any direct or indirect cost in the program.

<u>Final Regulatory Flexibility Analysis</u>. This rule will have no significant effect on small businesses.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, department of transportation, by s. 343.305(6)(b), Stats., the department of transportation hereby amends a rule interpreting s. 343.305(6)(b), Stats., relating to breath alcohol testing, approval and permit program.

SECTION 1. Trans 311.03(6) is renumbered 311.03(7).

SECTION 2. Trans 311.03(6) is created to read:

Trans 311.03(6) "Chief of the chemical test section" means the person assigned the responsibility for the administration and supervision of the breath alcohol testing, approval and permit program of the department.

SECTION 3. Trans 311.03(7) is renumbered 311.03(8).

SECTION 4. Trans 311.03(8) and (9) are renumbered 311.03(9) and (11) and amended to read:

Trans 311.03(9) "Instrument blank analysis" means a test of a room an ambient air sample to insure that the instrument produces a blank zero result.

(11) "Permit" means a certificate issued by the department authorizing an individual to perform breath alcohol testing using the instrument or <u>categories of</u> instruments specified thereon.

SECTION 5. Trans 311.03(10) is renumbered 311.03(12).

SECTION 6. Trans 311.03(10) is created to read:

Trans 311.03(10) "Lot" means an entire batch of reference solution.

SECTION 7. Trans 311.03(11) is renumbered 311.03(13).

SECTION 8. Trans 311.03(12) is renumbered 311.03(14) and amended to read:

Alco-Sensor II Alco-Sensor III Alco-Meter SD-2

Trans 311.05 APPROVAL OF CALIBRATING UNITS. All calibrating units for breath alcohol test instruments shall have the approval of the department chief of the chemical test section.

NOTE: The following calibrating units are approved for use in Wisconsin:

Smith & Wesson Mark II Simulator Smith & Wesson Mark IIA Simulator National Draeger Mark IIA Simulator National Draeger Mark II Simulator BA-500 Breath/Alcohol Simulator Toxitest II Toxitest, Model ABS 120 Guth Simulator Model 34C Alcohol Vapour Standard

SECTION 12. Trans 311.06(1), (2), (3)(intro.), (3)(a) and (b), (4) and (5) are amended to read:

Trans 311.06(1) Only methods approved by the department may be used to perform quantitative <u>breath alcohol</u> analysis of the breath to determine the alcohol content.

- (2) Techniques used in performing quantitative <u>breath alcohol</u> analysis of the breath shall be those which are designed to assure accuracy, detect malfunctions and to safeguard personnel and equipment.
- (3) Procedures for quantitative <u>breath alcohol</u> analysis of the breath shall include the following controls in conjunction with the testing of each subject:
- (a) Observation by a law enforcement person or combination of law enforcement persons, of the test subject for a minimum of 20 minutes prior to the collection of a breath specimen, during which time the test subject may did not have ingested ingest alcohol, regurgitated regurgitate, vomit or smoked smoke.

- (b) An instrument Instrument blank analysis.
- (4) The results of an analysis of breath for alcohol shall be expressed in terms of grams of alcohol per 210 liters of breath.
- (5) Methods and techniques used in performing qualitative <u>breath alcohol</u> analysis of the <u>breath</u> shall be approved by the department.

SECTION 13. Trans 311.07(2)(intro.) and (d) are amended to read:

Trans 311.07(2) Certification of any breath alcohol testing program shall be contingent upon the law enforcement agency's agreement to conform to and abide by all directives, orders or policies issued or to be issued by the department. These may shall include, but are not limited to, the following:

(d) Transmission of all program data or information requested in a manner and format prescribed by the department.

SECTION 14. Trans 311.09(1), (2)(intro.) and (3) are amended to read:

Trans 311.09(1) Training programs for the training of law enforcement agency personnel in the qualitative or quantitative ehemical breath alcohol analysis of the breath shall be approved by and under the direction of the department.

- (2) Applicants to attend an approved training program in the quantitative ehemical breath alcohol analysis of the breath shall meet the following qualifications:
- (3) Applicants to attend an approved training program in the qualitative ehemical breath alcohol analysis of the breath shall have the recommendation of the chief administrative officer of the employing agency.

SECTION 15. Trans 311.10(1)(b) is amended to read:

Trans 311.10(1)(b) Each test for accuracy shall include, but not be limited to, an instrument blank analysis and an analysis utilizing a calibrating unit, the. The result of which the calibrating unit analysis shall fall within 0.01 grams of alcohol per 210 liters of gas of the established reference value.

SECTION 16. Trans 311.10(1)(c) is created to read:

Trans 311.10(1)(c) The original reports of instrument maintenance and certifications shall be forwarded to and retained by the department.

SECTION 17. Trans 311.10(2) and (3)(intro.) are amended to read:

Trans 311.10(2) Each qualitative breath alcohol test instrument approved for use in this state shall be tested. checked for accuracy as follows:

- (a) The accuracy of the instrument shall be checked by an individual holding a valid permit for the operation thereof.
- (b) The tests and accuracy checks shall be conducted at intervals established by the department.
- (c) Each accuracy and calibration check shall consist of an analysis utilizing a calibrating unit, the results of which analysis shall fall within tolerances established by the department.
- (3) Reference solutions for use in calibrating units shall have the approval of the department chief of the chemical test section.

SECTION 18. Trans 311.11(1)(intro.), (a) to (c), (2), (5) and (6) are amended to read:

Trans 311.11(1) Permits to conduct qualitative or quantitative ehemical tests of the breath breath alcohol analysis for the purpose of determining the presence or concentration of alcohol in the breath shall be issued only to those persons who have successfully completed a course of instruction prescribed by the department. Permits shall:
