ORDER ADOPTING RULE

Analysis Prepared by the Wisconsin Department of Transportation

STATUTORY AUTHORITY: s. 114.37, Stats., by 1991 Wis. Act 91, and s. 85.16(1), Stats. STATUTE INTERPRETED: s. 114.37, Stats.

General Summary of Rule. This rule relates to the administration of the Department's "Land Loan" program. The interpreted statute invests the Department with the responsibility of promoting the state's interest in preserving and improving a safe and efficient air transportation system by means of a program to provide loans for advance land acquisition for airport projects.

1991 Assembly Bill 91 amended the statute interpreted. The amendment expanded the class of eligible program applicants to include owners of public-use airports. The changes to ch. Trans 54 will conform the rule to the amended statute.

Fiscal Impact. No fiscal impact is anticipated from the promulgation of this rule.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, department of transportation, by ss. 85.16(1) and 114.37, Stats., and 1991 Wis. Act 91, the department of transportation hereby adopts the amendment of a rule interpreting s. 114.37, Stats., relating to advance land acquisition loan program for airports.

SECTION 1. Trans 54.02(4) is amended to read:

Trans 54.02(4) "Sponsor" means the municipal owner or prospective municipal owner of a public-use airport in the Wisconsin state airport system plan, including a city, county,

town, or village, or owner of a public-use airport and any 2 or more such governmental units having joint ownership.

Effective Date. This rule shall take effect on the first day of the month following publication in the Wisconsin Administrative Register as provided in s. 227.22(2), Stats.
