The Wisconsin Department of Industry, Labor and Human Relations proposes an order to renumber ILHR 50.12 (4) (d) as (4) (e); amend ILHR 50.12 (3)(b) 1., 50.12 (3) (b) 2.; and create ILHR 50.12 (4) (d), 51.01 (105e), 52.24 and Appendix C relating to the designation of space for recyclable materials.

ANALYSIS OF PROPOSED RULES

Statutory authority:	Section	101.126,	Stats.
Statutes interpreted:	Section	101.126,	Stats.

In April of 1990, 1989 Wisconsin Act 335 was signed into law. Act 335, which relates to recycling, requires the department to establish rules such that public buildings designate adequate space for the separation, temporary storage and collection of recyclable materials likely to be generated by the building occupants.

The passage of Act 335 will effectively reduce the amount of solid waste disposed of in landfills. The law prohibits the landfilling and burning of various materials defined as recyclable materials; encourages the development of markets for post-consumer waste; and specifies the allocation of adequate space for the separation, temporary storage and collection of recyclable materials.

Section 101.126, Stats., as created by 1989 Wisconsin Act 335, contains provisions for new buildings for the inclusion of a separate room or designated area for the separation, temporary storage and collection of recyclable materials. This section also requires all public buildings built after the effective date of this rule and all buildings where an addition or alteration results in more than a 50% increase in area to comply with this rule.

The proposed rules establish which public buildings must comply with this rule and specify the approximate size of the room or area designated for the separation, temporary storage or collection of recyclable materials.

The law requires that the department consult with the Recycling Council in developing these rules. These rules were presented to the Recycling Council at their March 11, 1992 meeting with general agreement.

SECTION 1. ILHR 50.12 (3) (b) 1. is amended to read:

ILHR 50.12 (3) (b) 1. 'Plot plan.' The location of the building with respect to property lines and lot lines and adjoining streets, alleys and any other buildings on the same lot or property shall be indicated on the plot plan. For recycling space designated adjacent to a building, as specified in s. ILHR 52.24, the area and dimensions shall be indicated on the plot plan. A small scale plot plan shall be submitted on a 8 1/2" X 11" sheet for projects containing multiple buildings. For purposes of this requirement, a plot plan does not have to be a certified survey.

SECTION 2. ILHR 50.12 (3) (b) 2. is amended to read:

ILHR 50.12 (3) (b) 2. 'Floor plans.' Floor plans shall be provided for each floor. The size and location of all rooms, doors, windows, fire walls, toilet facilities, structural features, exit passageways, exit lights, fire alarms, standpipes, stairs and other pertinent information, including but not limited to adequate space within a building designated for collection, separation and temporary storage of recyclable materials, shall be indicated. Schematic exit plans shall be provided for large buildings, indicating normal paths of egress.

SECTION 3. ILHR 50.12 (4) (d) is renumbered ILHR 50.12 (4) (e).

SECTION 4. ILHR 50.12 (4) (d) is created to read:

ILHR 50.12 (4) (d) <u>Data for recycling space</u>. Verifiable data or calculations and specifications shall be submitted in accordance with s. ILHR 52.24 for determining adequate space for the separation, temporary storage and collection of recyclable materials, unless the space designated is based on the requirements identified in this code.

SECTION 5. ILHR 51.01 (105e) is created to read:

ILHR 51.01 (105e) "Recyclable material" means solid waste material prohibited for land disposal and incineration, that is separated, temporarily stored and collected. These materials include, but are not limited to, aluminum and glass containers, corrugated paper or container board, magazines, newspapers, office paper, foam polystyrene packaging, and plastic or steel containers.

SECTION 6. ILHR 52.24 is created to read:

ILHR 52.24 <u>RECYCLING SPACE</u>. (1) APPLICABILITY. All buildings under the scopes of chs. ILHR 54 to 62 shall provide a separate room or designated space within or adjacent to the building for the separation, temporary storage and collection of recyclable materials likely to be generated by the building occupants, under any of the following conditions:

(a) The construction of a new public building;

(b) An increase in the existing area of a public building which increases the gross floor area of the structure by 50% or more; or

(c) An alteration of 50% or more of the existing area of a public building that is 10,000 square feet or more in area.

Note: The collection and temporary storage of flammable and combustible materials is regulated in chs. ILHR 10 and 59. Owners of buildings where these materials are stored should consult these chapters for isolation and storage standards.

(2) DESIGNATED SPACE. Designated space for the separation, temporary storage and collection of recyclable materials shall be provided within or adjacent to all buildings under sub. (1), except where a separate trash collection room is provided. In buildings where a trash collection room is provided, a clearly designated space for recyclables shall be provided.

Note: See Appendix C for guidelines for recommended designated space.

(3) ROOMS FOR SEPARATION, COLLECTION AND STORAGE. (a) Separate rooms provided for the separation, collection and temporary storage of recyclable materials shall comply with s. ILHR 52.012 (2).

(b) When an automatic fire sprinkler system is provided, the system shall be designed and installed in an acceptable manner, and material may not be placed closer than 3 feet below sprinkler deflectors or discharge orifices.

(c) For buildings regulated under ch. ILHR 58, rooms provided for the separation, collection and temporary storage of recyclable materials shall comply with s. ILHR 58.24 or 58.62.

Note: Structural support for safe floor loads shall be in accordance with s. ILHR 53.11 (1) (d).

(4) STORAGE HEIGHT. The height of recyclable materials temporarily stored shall be limited so that stacked material is stable and secured against sliding or collapse.

(5) CLEARANCE. (a) Containers for the collection or temporary storage or the space designated as a collection or storage point may not be located so as to limit the use of exits, exit passageways, stairways, fire escapes or areas normally used for safe egress for the building occupants or in such a manner as to obstruct normal movement of employes in the performance of their duties.

(b) Where mechanical equipment is used in the collection, separation, temporary storage or removal of recyclable materials, sufficient safe clearance shall be provided for equipment turning and passage.

(6) PROHIBITIONS. Storage of recyclable materials is prohibited within furnace or mechanical rooms. If designated space is adjacent to a building, the area provided may not be within 5 feet of combustible walls, wall openings or roof eaves.

SECTION 7. Chapters ILHR 50 to 64 Appendix C is created to read:

APPENDIX C

The 1989 Wisconsin Act 335 requires the department to establish rules for public buildings such that adequate space is provided within or adjacent to buildings for the separation, temporary storage and collection of recyclable materials likely to be generated by the occupants of the building.

When verified amounts of previously generated recyclable materials are available, the following may be used to determine adequate space for the separation, temporary storage and collection of recyclable materials:

One cubic yard should be allocated for each 200 pounds of newspaper and mixed paper.

One cubic yard should be allocated for each 80 pounds of mixed or commingled recyclable materials.

The guidelines in the following table are provided for determining adequate space allocation when verified amounts of previously recyclable materials are not available. These guidelines are based on accumulation of recyclable materials likely to be generated by the building occupants for one week and one month, respectively.
