ORDER

An order of the Board of Nursing to amend N 2.04 (2) of the administrative code relating to official transcripts of nursing education from nursing schools outside of the United States.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 441.01 (3), Stats.

Statutes interpreted: s. 441.04, Stats.

The current rules of the Board of Nursing require that official transcripts from nursing schools outside of the United States be sent directly to the board office from the school. However, the Board of Nursing has determined that it would be reasonable to accept credentials from the Commission on Graduates of Foreign Nursing Schools based on the following reasons:

Foreign graduate applicants must request that official documentation of nursing education be sent directly from the school of nursing to the Commission on Graduates of Foreign Nursing Schools for evaluation to qualify for that examination. Since the Commission completes a more thorough review of the credentials and can assure us that the documents were received directly from the school of nursing, the board agrees that accepting the Commission's certified credentials would comply with the original intent of the rule as well as simplify the process for the applicant.

It is sometimes difficult for foreign graduates to obtain official transcripts from their school of nursing. Also, the political climate of some countries sometimes make it difficult for applicants to obtain such documentation.

It is also anticipated that receiving official documentation from the Commission would also assist some applicants in meeting a deadline for a specific examination the applicant may want or need to write.

The proposed rule amendment would maintain the current language to assure that official transcripts and/or credentials are submitted directly from the school of nursing for those applicants who have not had the Commission review their credentials prior to applying for the licensure examination.

TEXT OF RULE

SECTION 1. N 2.04 (2) is amended to read:

N 2.04 (2) Nursing schools outside of the United States shall forward, directly to the bureau, official transcripts of nursing education for applicants who were graduated from the school. The bureau may accept certified credentials directly from the commission on graduates of foreign nursing schools attesting to receipt of the original transcript or documentation of the applicant's nursing education directly from the school of nursing.
