An order of the Medical Examining Board to amend Med 8.05 (1) (b) and to create Med 8.05 (1) (cm) of the administrative code relating to certification requirements for physician's assistants.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b) and 227.11 (2), Stats., and s. 448.05 (5) (a) 1, Stats., as created by SECTION 3 of 1991 Wisconsin Act 180.

Statutes interpreted: s. 448.05 (5) (a) 1, Stats.

In this proposed rule-making order the Medical Examining Board is amending s. Med 8.05 (1) to comply with 1991 Wisconsin Act 180, relating to certification of physician's assistants to require that between April 29, 1992 and July 1, 1993, applicants for certification who are certified by the National Commission on Certification of Physician Assistants are eligible for certification even though they have not completed an approved physician's assistant training program.

TEXT OF RULE

SECTION 1. Med 8.05 (1) (b) is amended to read:

Med 8.05 (1) (b) Proof After July 1, 1993, proof of successful completion of an educational program, as defined in ss. Med 8.02 (4) and 8.04.

SECTION 2. Med 8.05 (1) (cm) is created to read:

Med 8.05 (1) (cm) Proof that the applicant is currently certified to assist primary care physicians by the national commission on certification of physician assistants.
