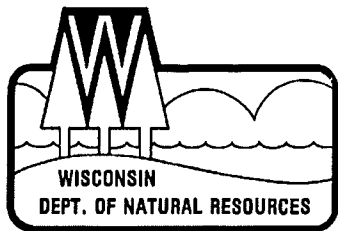

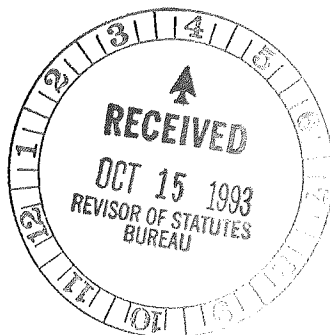

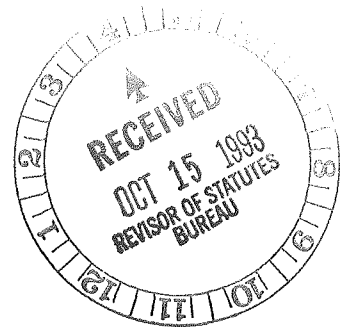

LAKE SUPERIOR COMMERCIAL FISHING BOARD
AMENDING RULES

Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 29.085, 29.174(3), 29.33(1) and (7) and 227.11(2)(a), Stats.

Statutes interpreted: ss. 29.085 and 29.174(2)(a), Stats.

By this order, the Lake Superior commercial fishing board authorizes permanent transfers of all or part of a fisher's individual lake trout harvest quota (tags) to other licensees. Current rules already authorize temporary (annual) transfers of Lake Superior lake trout quota tags.

SECTION 1. NR 25.08(2), as affected by Lake Michigan commercial fishing board proposed order no. FM-47-92, is amended to read:

NR 25.08(2) All or part of an individual licensee catch quota allotted under s. ~~NR 25.07(2)(a)3.a., (b), (bg), (br), (d), (e), (f), (g) or (h)3.~~ s. NR 25.07(1)(a) or (2)(a)3.a., (b), (bg), (br), (d), (e), (f), (g) or (h)3. may be permanently or temporarily transferred by the quota holder.

The foregoing rules were approved and adopted by the State of Wisconsin Lake Superior Commercial Fishing Board on May 18, 1993.

The foregoing rules were approved by the State of Wisconsin Natural Resources Board on August 19, 1993.

The rules contained herein shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
