

Statutory authority: ss. 29.174(3), 227.11(2)(a) and
227.16(2)(e), Stats.
Statutes interpreted: ss. 29.085 and 29.174(2)(a), Stats.

This order creates an exception to the waters affected by the northern bass zone sport fishing rules. Lower Clam lake lies north of and is separated from Clam lake by state highway 70, the boundary that defines the northern and southern bass zones. Lower Clam lake is connected to Clam lake and has similar characteristics. Sport anglers commonly travel between and fish both lakes. This order excludes Lower Clam lake from the northern bass zone rules and subjects it to the southern bass zone's open season, daily bag limit and minimum length limit (which govern Clam lake), thereby providing for uniform rules on these contiguous, connected waters.

SECTION 1. NR 20.03(1)(a)8m. is created to read:

Kind of fish and locality	Open season (both dates inclusive)	Daily bag limit	Minimum length (inches)
8m. Lower Clam lake (secs. 34 and 35, T39N, R6E), Burnett county	First Saturday in May to March 1	5 of each	14
