(CLEARINGHOUSE RULE 93-86)

ORDER

An order of the Medical Examining Board to amend Med 14.03 and to repeal and recreate Med 14.06 (2) relating to biennial registration.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 448.40 (1), Stats., and s. 440.08 (3) (b), Stats., as created by SECTION 3305 of 1991 Wisconsin Act 39.

Statutes interpreted: ss. 440.08 (3) (b) and 448.07 (1), Stats.

In this proposed rule-making order the Medical Examining Board promulgates rules outlining its authority under s. 448.07 (1), Stats., to require a licensee who has not renewed for a period of 5 years or more to meet educational or other requirements set by the board as a condition for license renewal. These proposed rules are the result of changes made in the law by 1991 Wisconsin Act 39.

These proposed rules specify that the Medical Examining Board may, in the exercise of its discretion, require licensees to demonstrate continued competence to practice.

These proposed rules also bring into conformity the dates of registration and notification of registration consistent with state statutes.

TEXT OF RULE

SECTION 1. Med 14.03 is amended to read:

Med 14.03 REGISTRATION REQUIRED; METHOD OF REGISTRATION. Each licensee shall register biennially with the board. On or before December-1 October 1 of each odd-numbered year the board shall mail to each licensee at his or her last known address as it appears in the records of the board an application form for registration. Each licensee shall complete the application form and return it with the required fee to the board office located at 1400 East Washington Avenue, P.O. Box 8935, Madison, Wisconsin 53708 prior to the next succeeding January-1 November 1. The board shall notify the licensee within 30 business days of receipt of a completed registration form whether the applicant for registration is approved or denied.

SECTION 2. Med 14.06 (2) is repealed and recreated to read:

Med 14.06 (2) Failure to renew a license by November 1 of odd-numbered years shall cause the license to lapse. A licensee who allows the license to lapse may apply to the board for reinstatement of the license as follows:

- (a) If the licensee applies for renewal of the license less than 5 years after its expiration, the license shall be renewed upon payment of the renewal fee and fulfillment of the continuing education requirements.
- (b) If the licensee applies for renewal of the license more than 5 years after its expiration, the board shall make such inquiry as it finds necessary to determine whether the applicant is competent to practice under the license in this state, and shall impose any reasonable conditions on reinstatement of the license, including oral examination, as the board deems appropriate. All applicants under this paragraph shall be required to pass the open book examination on statutes and rules, which is the same examination given to initial applicants.
