

ORDER

An order of the Barbering and Cosmetology Examining Board to amend BC 4.02 (2) relating to disinfectant agents for use in barbering and cosmetology establishments.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b) and 227.11 (2), Stats.

Statutes interpreted: s. 454.08 (4), Stats.

In this proposed order, the Barbering and Cosmetology Examining Board amends a rule relating to disinfectant agents approved for use in barbering and cosmetology establishments to permit the use of effective disinfectant agents regardless of the form in which the disinfectant agents are available, rather than explicitly permitting the use of only those disinfectant agents which are available as a spray.

TEXT OF RULE

SECTION 1. BC 4.02 (2) is amended to read:

BC 4.02 (2) Clipper blades, razors, scissors, tweezers and all other cutting instruments not contaminated by contact with blood shall be cleaned and disinfected prior to use. Disinfection may be accomplished as described in sub. (1) or by use of an EPA-registered germicidal spray preparation with demonstrated bactericidal, fungicidal and virucidal activity used according to manufacturer's instructions.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.22 (2) (intro.), Stats.
