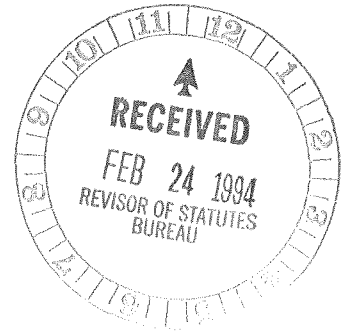
SECTION 1. Ind 80.61 (3) (em) is created to read:

IND 80.61 (3) (em) Waiver of requirements. The department may waive one or more requirements in pars. (b) to (e) if it determines that a waiver will not impair the construction owner's ability to ensure minimum confusion about insurance coverage and maximum safety on the construction project site.

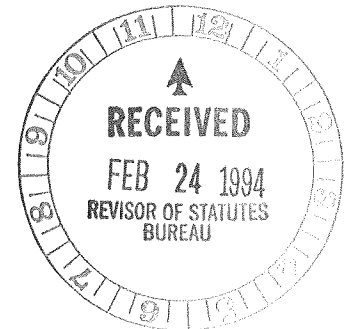
