IN THE MATTER OF an Order Adopting Rule **AMENDING** s. Trans 195.09(1), (2) and (6), Wis. Admin. Code, relating to fees for searches of division of motor vehicle records.

ORDER ADOPTING RULE

Analysis Prepared by the Wisconsin Department of Transportation

STATUTORY AUTHORITY: ss. 85.16(1) and 227.11, Stats.

STATUTES INTERPRETED: ss. 343.24(2) and (2m), and 342.09(3), Stats.

General Summary of Rule. On February 1, 1994, 1993 Wis. Act 16 increases the fee for each search of vehicle operator's records and providing copies of operator's records by \$1.00. This rule amendment reflects those changes, and also increases the fee for conducting a file search of vehicle title records by \$1.00.

<u>Fiscal Estimate</u>. The fiscal effect of this rule amendment is primarily created by the budget bill which designates the \$1 increase in s. 343.24(2) and (2m), Stats., which will provide an annual increase in revenue of an estimated \$3,486,000. This will be derived from an estimated \$3,028,000 mail, counter and automated driver record sales, and an estimated \$458,000 phone driver record sales.

An additional revenue increase of \$16,300 will be realized by increasing by \$1 the sale of an estimated \$16,300 vehicle record sales.

TOTAL ANNUAL REVENUE INCREASE: \$3,502,300.

<u>Final Regulatory Flexibility Analysis</u>. This rule will have no significant adverse effect on small businesses.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, department of transportation, by ss. 85.16(1) and 227.11, Stats., the department of transportation hereby amends a rule interpreting ss. 343.24(2) and (2m), and 342.09(3), Stats., relating to fees for searches of division of motor vehicle records.

SECTION 1. Trans 195.09(1), (2) and (6) are amended to read:

Trans 195.09(1) The Except as provided in sub. (2), the fee for the search of each single record identified in ss. Trans 195.03, 195.04, and 195.05, and 195.06 shall be \$2.00 \$3.00.

- (2) The fee for the search requested by telephone of each single record identified in s. Trans 195.03 shall be \$3.00 \$4.00.
- (6) The fee for each verification of records as identified in s. Trans 195.08 shall be \$2.00 \$3.00.
