

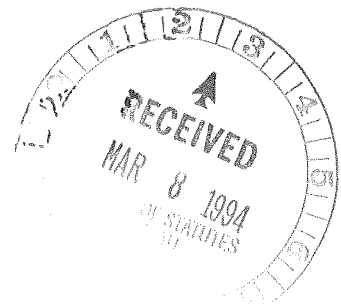
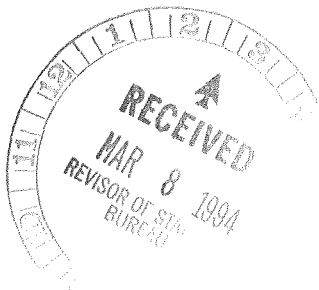

ORDER

An order of the Hearing and Speech Examining Board to amend HAS 6.03 (6) and 6.05 relating to licensure of speech-language pathologists and audiologists.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 440.03 (1), Stats., and s. 459.24 (2) (e), Stats., as affected by 1993 Wisconsin Act 66.

Statutes interpreted: s. 459.24 (2) (e), Stats.

In this proposed rule-making order the Hearing and Speech Examining Board amends ss. HAS 6.03 (6) and 6.05.

This proposed rule-making is the result of changes made in the law by 1993 Wisconsin Act 66 which amends s. 459.24 (2) (e), Stats., to permit an individual applying for a license to practice speech-language pathology to submit evidence of education and training which, as determined by the Hearing and Speech Examining Board, is substantially equivalent to passing the examination required under s. 459.26, Stats.

Sections HAS 6.03 (6) and 6.05 are being amended to reflect the board's determination that written verification of an applicant's clinical competence received directly from the American Speech-Language-Hearing Association (ASHA) constitutes satisfactory evidence that the applicant has completed education and training which is substantially equivalent to passing the examination required under s. 459.26, Stats., to determine fitness as a speech-language pathologist.

TEXT OF RULE

SECTION 1. HAS 6.03 (6) is amended to read:

HAS 6.03 (6) Written verification that the applicant has passed the NESPA examination required under s. HAS 6.05 or verification of clinical competence received directly from ASHA.

SECTION 2. HAS 6.05 is amended to read:

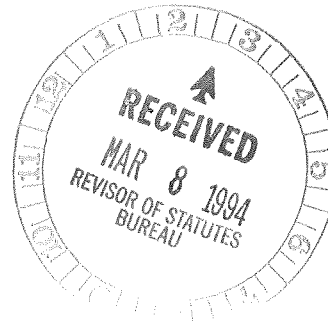
HAS 6.05 EXAMINATIONS. An applicant for licensure as a speech-language pathologist shall pass the NESPA examination required by ASHA for certification or submit written verification of clinical competence received directly from ASHA. An applicant for licensure as an audiologist shall pass the NESPA examination required by ASHA for certification or submit written verification of clinical competence from ASHA ~~as appropriate.~~

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.22 (2) (intro.), Stats.

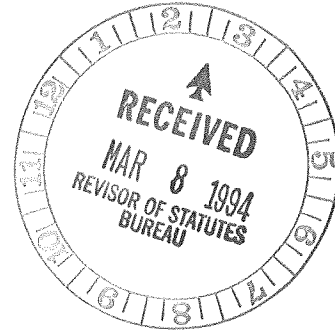
