



ORDER OF THE STATE EMERGENCY RESPONSE BOARD

AMENDING A RULE

NOTICE IS HEREBY GIVEN That pursuant to ss. 166.20 (7), Stats. and interpreting s. 166.20(7), Stats., and according to the procedure set forth in s. 227.16 (2) (e), Stats., the State Emergency Response Board will adopt the following rule as proposed in this notice, without public hearing unless, within 30 days after the publication of this notice (revisor to insert date), the State Emergency Response Board is petitioned for a public hearing by 25 natural persons who will be affected by the rule; a municipality which will be affected by the rule; or an association which is representative of a farm, labor, business or professional group which will be affected by the rule:

The Wisconsin State Emergency Response Board proposes an order to amend SERB 1.05 relating to a surcharge on fees paid by facilities housing hazardous chemicals.

ANALYSIS PREPARED BY THE STATE EMERGENCY RESPONSE BOARD:

Under the authority vested in s. 166.20(7) Stats. and interpreting s. 166.20(7), Stats., the State Emergency Response Board proposes to amend SERB 1.05 in order to clarify existing Board policy on the amount of the surcharge to be collected.

Chapter SERB 1

Amending A Rule

SECTION 1. SERB 1.05 is amended to read:


SERB 1.05 SURCHARGE. An owner or operator who fails to pay a fee under s. SERB 1.03 or 1.04 by on or before its due date shall pay a surcharge of 20% of the amount due unpaid balance of the fee due.

This rule shall take effect on the first day of the month commencing after the date of publication in the Wisconsin Administrative Register as provided in s.227.22(2)(intro), stats.
