

IN THE MATTER OF an Order Adopting Rule AMENDING s. Trans 115.04(3)(d)1 and 8, and (k), Wisconsin Administrative Code, relating to third party testing.

ORDER ADOPTING RULE

Analysis Prepared by the Wisconsin Department of Transportation

STATUTORY AUTHORITY: ss. 343.02(1) and 343.16(1)(b), Stats. STATUTE INTERPRETED: s. 343.16(1)(b), Stats.

General Summary of Rule. The amendments to this rule are to eliminate the requirement of the third party tester to enter and maintain the driver's social security number and the make of the commercial motor vehicle used during testing on the form which is maintained by the third party tester in an alphabetical file.

This rule making will also reduce the required minimum number of skills tests administered annually by a third party tester from 25 to 12.

<u>Fiscal Effect</u>. Promulgation of these changes will have no fiscal effect on the Department or local government.

<u>Final Regulatory Flexibility Analysis</u>. This rule making will have no effect on small businesses.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, department of transportation, by s. 343.02(1), Stats., the department of transportation hereby amends a rule interpreting s. 343.16(1)(b), Stats., relating to third party testing.

SECTION 1. Trans 115.04(3)(d)1 and 8, and (k) are amended to read:

Trans 115.04(3)(d)1 The driver's complete name, social security number, address, phone number and employer.

- (3)(d)8 The make and registration number of the CMVs used during the testing.
- (3)(k) Administer a minimum of 25 12 CDL skills tests per year.

(END OF RULE TEXT)


