## Chapter DOD 28

## HEALTH CARE PROVIDER LOAN ASSISTANCE PROGRAM

DOD	28.01 Purpose	DOD	28.03 Priorities among eligible applicants
DOD	28.02 Definitions	DOD	28.04 Application process

<u>DOD 28.01 PURPOSE</u>. The purpose of this chapter is to establish the procedures under which health care providers may apply for assistance under this chapter and to establish priorities among eligible applicants in the event that the number of applicants exceeds available funding.

## DOD 28.02 DEFINITIONS.

- (1) "Department" means the department of development.
- (2) "Health care provider" has the meaning contained in s. 560.184 (1)(b), Stats.
- (3) "Nurse-midwife" means a person who practices nurse-midwifery in accordance with s. 441.15, Stats.
- (4) "Nurse practitioner" has the meaning contained in 632.895 (8) (a) 3, Stats.
- (5) "Physician assistant" has the meaning contained in s. 448.01 (6) Stats.
- (6) "Primary care" means basic health care services including general assessment, treatment, and management of common acute and chronic medical conditions, health promotion and disease prevention, and prenatal care and delivery services.
- (7) "Primary care health professional shortage area" has the meaning contained in s.560.184 (1) (c), Stats.

DOD 28.03 PRIORITIES AMONG ELIGIBLE APPLICANTS. (1) Any health care provider who practices in a primary care health professional shortage area and who provides primary care is eligible for educational loan repayment as provided in s. 560.184 (4), Stats.

(2) If the cost of repaying the loans of all eligible applicants, when added to the cost of loan repayments scheduled under existing agreements, exceeds the total amount in the appropriation under s. 20.143 (1) (fc) and (jL), Stats., the department shall establish priorities among eligible applicants based upon the following considerations:

- (a) <u>Extremely high need for medical care</u>. The degree to which there is an extremely high need for medical care in the primary care health professional shortage area in which the eligible applicant proposes to practice.
- (b) <u>Health care provider retention</u>. The likelihood that an eligible applicant will remain in the primary care health professional shortage area in which he or she desires to practice after the loan repayment period.
- (c) <u>Per capita income</u>. The per capita income of the primary care health professional shortage area in which an eligible applicant desires to practice.
- (d) <u>Financial support for health care provider recruitment and</u> <u>retention</u>. The financial or other support for health care provider recruitment and retention provided by individuals, organizations or local governments in the primary care health professional shortage area in which an eligible applicant desires to practice.
- (e) <u>Geographic distribution</u>. The geographical distribution of the health care providers who have entered into loan repayment agreements under this section and the geographic location of the primary care health professional shortage area in which an eligible applicant desires to practice.
- (f) <u>Length of service</u>. The degree to which the medical service is new to the primary health care professional shortage area.
- (g) Loan balance. The loan balance of the eligible applicant.

<u>DOD 28.04 APPLICATION PROCESS</u>. (1) Applications shall be in such form as the department may require and shall contain the following information:

- (a) Evidence of health care professional educational program attendance.
- (b) Evidence of licensure or certification as a nurse-midwife, nurse practitioner or physician assistant.
- (c) Evidence of indebtedness and outstanding balance.
- (d) The location of the applicant's current or proposed practice.
- (e) Evidence that the provider practices or will practice primary care in a primary care health professional shortage area.
- (f) The length of time the health care provider has practiced in the primary care health professional shortage area.
- (g) Information about the likelihood that the applicant will remain in the primary care health professional shortage area after the loan repayment period.

- (h) Any other information the department may require to make a determination in accordance with the provisions of s. 560.184, Stats., and this chapter.
- (2) The department shall prepare application materials that it may update as necessary.
