ORDER

An order of the Board to Nursing to amend N 2.05 (6) (title), (a) and (b) relating to reexamination fees.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2), 440.03 (2), 440.06 and 441.01 (3), Stats.

Statutes interpreted: s. 440.06, Stats.

In this proposed rule-making order the Board of Nursing amends s. N 2.05 (6) (b) as a result of rule-making by the Department of Regulation and Licensing, Clearinghouse Rule 93-113, effective December 1, 1993. In Clearinghouse Rule 93-113, the Department of Regulation and Licensing repealed and recreated s. RL 4.04 to reflect revisions to s. 440.05 (1), Stats., contained in 1993 Wisconsin Act 16. Listing of specific fees is removed from s. RL 4.04 and replaced by a rule which requires the department to maintain and make available to the public a list of current examination fees.

TEXT OF RULE

SECTION 1. N 2.05 (6) (title), (a) and (b) are amended to read:

N 2.05 (6) FAILURE AND REEXAMINATION. (a) An applicant who fails to earn a passing score on the examination for licensure may be ~~re-examined~~ reexamined, but not sooner than the next scheduled test date.


(b) The applicant shall request the ~~re-examination~~ reexamination at least 28 days prior to the examination date by filing with the bureau a written request and ~~re-examination~~ reexamination fee ~~specified in s. RL-4.04.~~




