ORDER

An order of the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors to amend A-E 5.04 (7) and 6.05 (8) relating to examination fees.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2), 440.03 (2) and 440.06, Stats.

Statutes interpreted: ss. 440.06 and 443.10 (2) (b), Stats.

In this proposed rule-making order the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors amends ss. A-E 5.04 (7) and 6.05 (8) as a result of rule-making by the Department of Regulation and Licensing, Clearinghouse Rule 93-113, effective December 1, 1993. In Clearinghouse Rule 93-113, the Department of Regulation and Licensing repealed and recreated s. RL 4.04 to reflect revisions to s. 440.05 (1), Stats., contained in 1993 Wisconsin Act 16. Listing of specific fees is removed from s. RL 4.04 and replaced by a rule which requires the department to maintain and make available to the public a list of current examination fees.

TEXT OF RULE

SECTION 1. A-E 5.04 (7) is amended to read:

A-E 5.04 (7) EXAMINATION PROCEDURE. An applicant for a designer examination who fails an examination on any part of an examination may retake any part of the examination failed at a regularly-scheduled administration of the examination. If an applicant fails to pass on reexamination of the parts failed, or the current examination parts equivalent to the parts failed, within 4 years from the date of receipt of the results of the first failure of the examination or any part of the examination, the applicant is required to take and pass the entire examination. If the applicant retakes the entire examination, the applicant shall pay the original examination fee under ehr-RL 4 s. 440.05 (1), Stats.

Note: A list of all current examination fees may be obtained at no charge from the Office of Examinations, Department of Regulation and Licensing, 1400 East Washington Avenue, P.O. Box 8935, Madison, WI 53708.

SECTION 2. A-E 6.05 (8) is amended to read:

A-E 6.05 (8) REEXAMINATION PROCEDURE. An applicant for a land surveyor examination who fails an examination or any part of an examination may retake any part of the examination failed at a regularly-scheduled administration of the examination. If an applicant fails to pass on reexamination of the parts failed, or the current examination parts equivalent to the parts failed, within 4 years from the date of receipt of the results of the first failure to the examination or any part of the examination, the applicant is required to take and pass the entire examination. If the applicant retakes the entire examination, the applicant shall pay the original examination fee under ehr-RL 4 s. 440.05 (1), Stats. The board shall determine which parts of a current examination are equivalent to the examination parts failed by an applicant.
