AMENDING AND CREATING RULES

IN THE MATTER of amending s. NR 45.12(2)(c)1. and
creating s. NR 45.12(2)(c)5. of the Wisconsin Administrative
Code pertaining to camping fees.

Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 27.01(10)(h), and 227.11(2)(a), Stats.

Statutes interpreted: ss. 27.01(2)(f), (10)(f) and (h), Stats.

The proposed rules:

1. Increase electrical fee.
2. Create weekend and holiday family camping fees.

SECTION 1. NR 45.12(2)(c)1. is amended to read:

NR 45.12(2)(c)1. Electricity. \$2.00-\$3.00 per unit per day- night.

SECTION 2. NR 45.12(2)(c)5. is created to read:

\$2.00 per night

NR 45.12(2)(c)5. Additional weekend and holiday family
camping fees for class "A" and "B" campgrounds and the Carrol,
Clear, Crystal, Firefly, Indian Mound and Musky campgrounds in
the American Legion Northern Highland state forests beginning
Memorial Day weekend through Labor Day.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board
on March 24, 1994.

The foregoing rules shall take effect the first day of the month following publication in the Wisconsin
administration register as provided in s. 227.22(2)(intro.), Stats.
