

# VETERINARY EXAMINING BOARD ADOPTING RULES (CLEARINGHOUSE RULE 94-54)

#### ORDER

An order of the Veterinary Examining Board to amend VE 7.03 (1) and (2) (intro.) relating to patient records.

#### ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 453.03 (1), Stats.

Statutes interpreted: s. 453.068 (3), Stats.


This proposed rule-making order clarifies that individual patient records must be kept. The current rule does not specify that the patient records have to be individual records.

#### **TEXT OF RULE**

SECTION 1. VE 7.03 (1) and (2) (intro.) are amended to read:

VE 7.03 (1) A veterinarian shall maintain medical individual patient records on every patient administered to by the veterinarian other than food and fiber patients for a period of not less than 3 years after the date of the last entry. The veterinarian shall keep individual client records for food and fiber patients for 3 years after the date of the last entry.

(2) (intro.) The medical individual patient record shall contain clinical information pertaining to patients other than food and fiber patients with sufficient information to justify the diagnosis and warrant treatment, including information regarding each of the following matters which apply:



The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.22 (2) (intro.), Stats.
