ORDER

An order of the Medical Examining Board to amend Med 8.04 relating to accreditation of educational programs for physician's assistants.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 448.40 (1), Stats.

Statutes interpreted: s. 448.05 (5) (a) and (b), Stats.

This proposed rule-making order is the result of a change made by the American Medical Association of the accreditation of physician's assistants educational programs. The Council on Medical Education of the American Medical Association will no longer provide accreditation of these programs. It will now be the responsibility of the Committee on Allied Health Education and Accreditation.

The amendment to s. Med 8.04 is necessary to bring the rule into conformity with the current organization that will provide the accreditation.

TEXT OF RULE

SECTION 1. Med 8.04 is amended to read:

Med 8.04 <u>EDUCATIONAL PROGRAM APPROVAL</u>. The board shall approve only educational programs accredited and approved by the council on medical education <u>committee on allied health education and accreditation</u> of the American medical association.
