

ORDER OF THE
CONTROLLED SUBSTANCES BOARD
CREATING, AMENDING AND REPEALING RULES



NOTICE IS HEREBY GIVEN That pursuant to s. 161.24 Stats., and according to the procedure set forth in s. 227.16 (2) (e), Stats., the Controlled Substances Board will create CSB 2.23 amending s. 161.14 (4) (wg), amend s. 161.17 (7) (intro.) and repeal s. 161.18 (3) (c) was herein proposed without public hearing, unless, within 30 days after publication of the notice of proposed rulemaking the Board would be petitioned for a public hearing by 25 persons who will be affected by the rule changes, a municipality which will be affected by the rule changes, or an association which is representative of a farm, labor, business or professional group which will be affected by the rule changes. A request for public hearing was not made in the time allowed by statute and the rule process proceeded to legislative review. No action was taken by the legislative committees on the proposed rule in the allotted statutory time and the rules are therefore being transmitted to the Secretary of State for registration and the Revisor of Administrative Codes for publication.

Analysis Prepared by the Controlled Substances Board

This order revises the controlled substances schedules of the Wisconsin Controlled Substances Act to bring them into conformity to the federal controlled substances act as required by s. 161.11 (4), Stats. The Drug Enforcement Administration, of the Department of Justice, annually excepts and publishes in the Federal Register certain compounds of steroids. This order brings the Wisconsin Controlled Substances Act into compliance with those Federal exceptions. The drug 4-Bromo-2,5-Dimethoxyphenethylamine has been temporarily scheduled by DEA into Schedule I. Under s.161.11 (4), Stats., the Wisconsin Uniform Controlled Substances Act, the state is required to similarly control the substance.

Glutethimide, located in Schedule III, s.161.18 (3) (c), is being repealed from the schedules. Glutethimide was moved by Federal scheduling to Schedule II and by CSB 2.21 (effective 12/92) but was not deleted from Schedule III as necessary. This is a technical correction.

Pursuant to authority vested in the Controlled Substances Board by ss. 161.11 (1), 161.11(4), 161.18 (6) and 161.24, Stats., the Controlled Substances Board proposes to adopt CSB 2.23 WI Administrative Code to revise various sections of 161 Stats., as follows.

CSB 2.23 Additions and amendments to drug schedules.

SECTION 1. 161.14 (4) (wg) is created to read:

s. 161.14 (4) (wg) 4-bromo-2,5-dimethoxyphenethylamine;

SECTION 2. 161.17 (7) (intro.) of the statutes is amended to read:

s. 161.17 (7) (intro.) ANABOLIC STEROIDS. Unless specifically excepted under federal regulations, any ~~Any~~ compound, material, compound, mixture or preparation containing any quantity of the following anabolic steroids, including any of their esters, isomers, esters of isomers, salts and salts of esters, isomers and esters of isomers, whenever those esters, isomers,

esters of isomers, salts and salts, esters, isomers and esters of isomers exist within the specific chemical designation:

SECTION 3. 161.18 (3)(c) of the statutes is repealed.

The rules contained in this order shall take effect on the first day of the month following publication in the Wisconsin Administrative Register as provided in s. 227.22(2), Stats.
