ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
AMENDING RULES

IN THE MATTER of amending s. NR 25.06(2)-(b)1. of .
the Wisconsin Administrative Code pertaining to . FM-44-94
commercial fishing for yellow perch on Green Bay .

Analysis Prepared by the Department of Natural Resources

Statutory authority: ss. 29.085, 29.174(3), 29.33(1) and (7) and 227.11(2)(a), Stats.

Statutes interpreted: ss. 29.085 and 29.174(2)(a), Stats.

The order affects Lake Michigan commercial fishing rules. It decreases the total allowable annual commercial harvest of yellow perch from zone 1 of Lake Michigan (i.e., Green Bay). The total allowable annual commercial harvest of yellow perch is reduced from 400,000 pounds to 300,000 pounds.

SECTION 1. NR 25.06(2)(b)1. is amended to read:

NR 25.06(2)(b)1. The total allowable commercial harvest in zone 1 for any license year may not exceed ~~400,000~~ 300,000 pounds.

The foregoing rules were approved by the State of Wisconsin Natural Resources Board on October 27, 1994.

The rules contained herein shall take effect on the first day of the month following publication in the Wisconsin administrative register, as provided in s. 227.22(2)(intro.), Stats.
