

STATUTORY AUTHORITY. Pursuant to the authority vested in the department of industry, labor and human relations by ss. 101.02(1), 108.04(2)(b), 108.14(2), and 227.11(2), Stats., the department hereby proposes to repeal ILHR 126.04(2)(b)2; to renumber ILHR 126.04(2)(b)3; and to amend ILHR 126.02(3), 126.03(intro.), 126.03(2)(b) and (c), 126.04(2)(b)1, and 126.05 (intro.).

The Wisconsin Department of Industry, Labor and Human Relations proposes an order to repeal ILHR 126.04(2)(b)2; to renumber ILHR 126.04(2)(b)3; and to amend ILHR 126.02(3), 126.03(intro.), 126.03(2)(b) and (c), 126.04(2)(b)1, and 126.05 (intro.).

Statutory Authority: ss. 101.02(1), 108.04(2)(b), 108.14(2) and 227.11(2)

Statutes Interpreted: ss. 108.04(2)(a) and (b)

ANALYSIS OF PROPOSED RULES PREPARED BY: THE DEPARTMENT OF INDUSTRY, LABOR AND HUMAN RELATIONS

Section 108.04(2), Stats., provides that a claimant for unemployment compensation must register for work. The statute authorizes the Department of Industry, Labor and Human Relations (Department) to promulgate rules establishing the requirements for work registration.

The Department has promulgated permanent rules establishing the requirements with which a claimant must comply to satisfy the work registration requirement. These rules are set forth in Chapter ILHR 126.

Wisconsin was one of only a few states which were chosen by the U.S. Department of Labor (DOL) to participate in a project for the purpose of studying the effectiveness of various types of job search assistance services. These amendments to Chapter ILHR 126 are necessary in order to meet the federal requirement that claimants assigned to the demonstration project who fail to participate in the project will be found ineligible for unemployment compensation benefits unless they have justifiable cause for their failure to participate. This rule provides that a claimant will not be considered to have met the statutory work registration requirement if s/he has been assigned to, but is not participating in, the demonstration project.

Section ILHR 126.02 has been amended to specify that the Job Search Assistance Demonstration Project is a reemployment program approved by the department for the purpose of meeting the statutory work registration requirement.

Section ILHR 126.03 has been amended to specify that the work registration requirement will be waived if the claimant has already been referred to the Job Search Assistance Demonstration Project and has satisfactorily completed his/her participation in that project.

Section ILHR 126.04 has been amended to provide that mere selection to participate in the Job Search Assistance Demonstration Project is not sufficient to meet the work registration requirement.

Section ILHR 126.05 has been amended to serve as a listing of justifiable cause for failure to participate in any reemployment program approved by the department for the purpose of meeting the work registration requirement.

SECTION 1. ILHR 126.02 (3) is amended to read:

(3) A claimant shall be considered registered for work if he or she is enrolled in or otherwise complying with department directives directions concerning other reemployment programs approved by the department for this purpose, or if the claimant is not complying but has justifiable cause for failure to participate under s. ILHR 126.05. Such programs include, but are not limited to, the job search assistance demonstration project.

SECTION 2. ILHR 126.03(intro.) is amended to read:

ILHR 126.03 WAIVER OF WORK REGISTRATION REQUIREMENT. Under s. 108.04(2)(b), Stats., the department may waive a claimant's work registration requirement. The department shall waive the a claimant's work registration requirement for any week if:

SECTION 3. ILHR 126.03(2)(b) and (c) are amended to read:

- (b) Has been referred <u>during the current benefit year</u> for reemployment services <u>or to the</u> job search assistance demonstration project; and
- (c) Has satisfactorily completed such services or project participation.

SECTION 4. ILHR 126.04(2)(b)1 is amended to read:

1. The claimant has not been referred for reemployment services; or

SECTION 5. ILHR 126.04(2)(b)2 is repealed.

SECTION 6. ILHR 126.04(2)(b)3 is renumbered 126.04(2)(b)2.

SECTION 7. ILHR 126.05(intro.) is amended to read:

126.05 JUSTIFIABLE CAUSE FOR FAILURE TO PARTICIPATE. The department may find that a claimant has justifiable cause for failing to participate in reemployment services or other department approved reemployment programs in any week. Justifiable cause includes, but is not limited to, the following:

This rule shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
