**LIRC 4.01 Petitions for commission review.** (1) A petition for commission review of the findings and order of a department of industry, labor and human relations administrative law judge shall be received within 21 days from the date of mailing of the findings and order to the parties and during regular office hours by an employe of the equal rights division of the department at:

(a) The Equal Rights Division, 819 North Sixth Street, Milwaukee, Wisconsin 53203, or

(b) The Central Administrative Office of the Equal Rights Division, 201 East Washington Avenue, P.O. Box 8928, Madison, Wisconsin 53708.

**LIRC 4.02 Transcripts.** (1) Transcripts of the testimony at hearings before department administrative law judges may be obtained according to s. Ind 88.17, or, in fair housing, s. ILHR 220.21.

(2) Review by the commission shall be based on the record of the case, including a transcript of the testimony,

where the record has been transcribed before the administrative law judge prepared a decision, under s. Ind 88.18 (5).

**LIRC 4.03 Actions for judicial review.** Judicial review of any commission order or decision shall be commenced in the manner and upon the grounds specified in ss. 227.52 to 227.57, Stats.
