PROPOSED ORDER OF THE WISCONSIN GAMING COMMISSION ADOPTING RULES

The Wisconsin Gaming Commission approves an order to renumber and amend RACE 13.05 (3) (b), (c), (d), (e), (f) and (g), amend RACE 10.09 (2) (e) 2., 13.05 (2) (title), (a), (b), (c), and (d), (4) and (5), 20.04 (5), and repeal and recreate RACE 13.05 (1), relating to pari-mutuel racing totalizator license fees, association occupational license fees, greyhound owner license fees, kennel license fees and food service concessionaire license fees.

ANALYSIS PREPARED BY THE WISCONSIN GAMING COMMISSION

Summary:

SECTION 1. RACE 10.09 (2) (e) 2. is amended to increase the program revenues generated from totalizator license fees. The current rule is dependent upon the pari-mutuel handle, whereas the new fee schedule will be dependent upon the number of performances. The new fee schedule increases the fee charged per performance from approximately \$6.00 to \$15.00.

The current rule for totalizator license fees assesses a fee of four-thousandths of one percent of the handle generated during the preceding calendar year at each racetrack at which the applicant has applied to operate a totalizator system. Presently, it would generate approximately \$8,400 in revenues. This equates to approximately \$6.00 per performance paid by the totalizator companies. The proposed flat rate fee of \$15.00 per performance (based on 1,417 performances requested in 1995) would generate \$21,255 in totalizator license fees. The noted fees are assessed directly to the totalizator companies, AmTote and United Tote, not to the associations.

SECTION 2. RACE 13.05 (1) is repealed and recreated to list the licenses in alphabetical order to facilitate the location of a particular association occupational license and to increase the association occupational license fees. The new schedule of association occupational license fees is more specific with respect to distinct categories for racetrack

employes that were previously licensed as "all other occupational licenses." By detailing specific license categories, seventeen new categories were formed and three previous categories were renamed. The term "replacement license" is for employes that have lost their license or had it stolen.

The list of new or renamed categories and the types of employment positions included for these categories are as follows:

- (a) Administrative [secretaries, accountants, receptionists, etc.];
- (am) Admissions [ticket takers, cashiers, ushers, parking attendants, valets];
- (b) Adoption Program [adoption director and any assistants];
- (c) Assistant Director of Racing [person assumes duties of director in their absence];
- (d) Assistant Mutuel Manager [person assumes duties of manager in their absence]; (em) Brake Man [person responsible for stopping the lure];
- (gm) Delivery [vendors who regularly deliver goods to restricted areas during performance hours;
- (i) Emergency Medical [medical assistance personnel located at the racetrack];
- (im) Food and Beverage [food servers, bartenders, busboys, dishwashers, etc.];
- (I) Maintenance/Housekeeping [janitors, cleaners, landscapers, electricians, etc.];
- (Im) Money Room [money counters, bookkeepers];
- (nm) Patrol Judge [responsible for parading greyhounds];
- (p) Publicity/Marketing [public relations, marketing, group sales, etc.];
- (q) Racing Secretary's Office [data processors that enter racing statistics];
- (qm) Replacement License [for someone who loses a license];
- (rm) Starter [person responsible for loading greyhounds into starting box];
- (tm) Track Maintenance [track superintendent, graders, rakers, tractor drivers, etc.];
- (u) Vet. Assistant-Association [association's practicing vet's helper];
- (um) Video [film patrol, television camera operators, closed circuit TV technicians].

SECTION 3. RACE 13.05 (2) (a), (b), (c) and (d) are amended to increase the program revenues generated from greyhound owners license fees. The title replaces the word "dog" with "greyhound" owner licenses to remain consistent with the term "greyhound" used throughout the racing rules.

SECTION 4. The term "kennel owner" in RACE 13.05 (3) (a) is not being amended and does not appear in this section. The fee for kennel owner in (3) (a) has not been changed and remains the same at \$750.00.

The term "kennel operator" in RACE 13.05 (3) (b) has been deleted because it is redundant with the term "kennel owner." RACE 13.05 (3) (c), (d), (e), (f) and (g) are renumbered to (3) (b) to (f), respectively. The fee for the renumbered (3) (b) remains the same at \$50.00. The renumbered subsections of (3) (c), (d), (e) and (f) are amended to increase the program revenues generated from kennel license fees.

SECTION 5. RACE 13.05 (4) and (5) are amended to increase the program revenue generated from all other occupational license fees not specifically identified in RACE 13.05 (1).

SECTION 6. RACE 20.04 (5) is amended to increase the program revenues generated from food service concessionaire fees. The new fee schedule increases the fee charged per performance from \$5.00 to \$10.00.

The increase in food service concessionaire fees from the current \$5.00 to the proposed \$10.00 per performance fee will generate \$14,170 in revenues. The identified amount is an increase of \$7,085 and is an obligation of the following food service concessionaires: Dairyland Greyhound Park, Inc. (\$4,420); Ogden Food Service at St. Croix Meadows (\$3,470); Track Concessions, Inc. at Geneva Lakes Kennel Club (\$3,660); and Wisconsin Sportservice, Inc. at Wisconsin Dells Greyhound Park (\$2,620).

The existing fee structure for occupational license fees ranges from \$20.00 (parking, lead-outs, food and beverage) to \$750.00 (kennel owner) and proposes an average 16% increase. For the 1994 season, approximately 4,000 occupational licenses will be issued generating \$168,500 in licensing-related revenues. The licensing categories with the most individuals include 986 greyhound owner licenses (\$40.00); 540 food and beverage licenses (\$20.00); and 430 lead-out licenses (\$20.00).

With the proposed fee increases for occupational licenses, the Racing Division estimates a \$26,960 increase in revenues raising the total from \$168,500 to \$195,460 based upon an equivalent number of licenses issued in the respective categories. Overall, the proposed schedule increases the average license fee 16% from \$42.12 to \$48.86. The noted fee increases will be the first since the initial promulgation of administrative rules in 1990. Overall, the proposed fee structures are projected to increase license revenues by \$50,000 in FY 1994-95.

In the case of renewals of license, the applicant shall, file a written acceptance with the board commission and make payment of the required license fee, in the The amount of four thousandths of one percent (.00004) of the handle generated during the preceding calendar year the license fee is based upon the number of

performances scheduled to be held at each racetrack at which the applicant has applied been approved to operate a totalizator system, such license fee not to exceed \$10,000 annually at any one racetack. The fee of \$15.00 will be applied to each performance that the racetrack is granted.

The fee for the license for the first year of the operation shall be \$1,500 for food service concessionaires. Subsequent license fees for food service concessionaires shall be \$5.00 \$10.00 per performance granted to the track racetrack at which the licensee operates. All other concessionaires will be required to pay an annual \$100 \$150 license fee.

This rule shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22 (2) (intro.), Stats.
