An order of the Examining Board of Architects, Landscape Architects, Professional Geologists, Professional Engineers, Designers and Land Surveyors to amend A-E 4.08 (3) relating to the examination application deadline.

ANALYSIS

Statutes authorizing promulgation: 15.08 (5) (b) and 227.11 (2), Stats.

Statutes interpreted: s. 443.09 (5), Stats.

This proposed rule-making order of the Examining Board of Architects, Landscape Architects, Professional Geologists, Professional Engineers, Designers and Land Surveyors relates to the application for examination deadline. Under the current rule, an application for examination must be filed with the board not later than 2 months before the scheduled date for the examination.

The proposed rule would decrease the examination application deadline from 60 days to 45 days for those applicants applying for reexamination who may not have been notified of the results from the previous examination prior to the deadline for applying for the next examination.

TEXT OF RULE

SECTION 1. A-E 4.08 (3) is amended to read:

A-E 4.08 (3) APPLICATION FOR EXAMINATION. An application for examination must be filed with the board no later than 2 months 60 days before the scheduled date for the examination. An applicant applying for reexamination shall file the application for reexamination no later than 45 days before the scheduled date for the next examination.
