

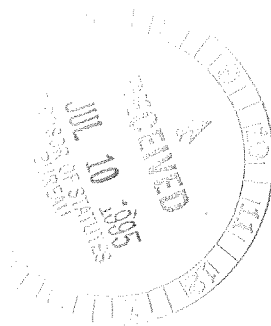



ORDER OF THE
STATE SUPERINTENDENT OF PUBLIC INSTRUCTION
CREATING/AMENDING RULES

The state superintendent of public instruction hereby amends PI 14.01(1)(c) and creates PI 14.01(1)(c)2 and (3), relating to school district membership reporting.

ANALYSIS BY THE DEPARTMENT OF PUBLIC INSTRUCTION

Statutory authority: ss. 121.05(4) and 227.11(2)(a), Stats.

Statute interpreted: s. 121.05(4), Stats.

1993 Wisconsin Act 395 provides that, beginning in the 1994-95 school year, the school board of a school district in which a foster or group home that is not exempt under s. 70.11, Stats., is located may submit a report to the state superintendent to adjust the school district's membership count. The state superintendent must then adjust the school district's membership based on the report and must make proportional adjustments to the memberships of the school district in which the pupil was previously enrolled during that school year.

The proposed amendments to ch. PI 14 allow for school district membership adjustment as provided for under the Act.

1 **SECTION 1.** PI 14.01(1)(c) is amended to read:

2 PI 14.01(1)(c) In the event a pupil has been absent all days during the school year prior to and on the
3 date specified, ~~an~~ if either of the following occurs:

4 1. An application has been made for formal homebound instruction as of the date specified and
5 documentation exists to support this application.

6 **SECTION 2.** PI 14.01(1)(c)2 and (3) are created to read:


7 PI 14.01(1)(c)2 A group and foster home membership report has been submitted by a school board of a
8 school district in which a foster or group home that is not exempt from property taxation under s. 70.11, Stats.,
9 is located as provided for under s. 121.05(4), Stats.

10 (3) If a pupil is included in the official enrollment as a result of a report filed under sub. (1)(c)2, the
11 school district in which the pupil was previously enrolled shall file a group and foster home membership report
12 representing a corresponding decrease in their official enrollment upon request by the department.

13 NOTE: The Group and Foster Home Membership Report may be obtained at no charge by writing to the
14 Wisconsin Department of Public Instruction, School Financial Services, P.O. Box 7841, Madison, WI 53707-
15 7841.

The rules contained in this order shall take effect on the first day of the month commencing after the date of publication in the Wisconsin Administrative Register, as provided in s. 227.22(2)(intro.), Stats.
