


Note: Chapter NR 11 as it existed on October 31, 1982 was repealed and a new chapter NR 11 was created effective November 1, 1982.

NR 11.01 Waterfowl closed area. A closed season is established in the following areas as posted with department signs. No person may hunt or trap any species of wild animal thereon during the open seasons on waterfowl established in s. NR 10.01. Legally killed or crippled game may be retrieved by dog or hand.

(1) MANITOWOC COUNTY. (a) *Collins marsh.* Township 19 north, range 21 east, town of Rockland.




(2) ST. CROIX COUNTY. (a) *Twin lakes*. Township 29 north, range 18 west, town of Warren.


NR 11.031 Waterfowl closed area; trapping permitted. A closed season is established in the following areas posted with department signs. No person may hunt any species of wild animal thereon during the open season on waterfowl established in s. NR 10.01 (1) (b) and (g). Legally killed or crippled game may be retrieved from such areas by dog or hand.

(1) BROWN COUNTY. (a) *Sensiba*. Township 25 north, range 20 east, town of Suamico.



NR 11.05 Migratory bird closed area; trapping permitted. A closed season is established in the following areas as posted with department signs and no person may hunt migratory birds thereon at any time. Legally killed or crippled game may be retrieved by dog or hand.


(1) DODGE COUNTY. (a) *Horicon Marsh wildlife area*. Township 12 north, range 16 east, town of Williamstown.





NR 11.06 Lake closed area; trapping permitted. A closed season is established in the following areas posted with department signs. No person may hunt or disturb waterfowl during the open seasons or disturb waterfowl during the open seasons on waterfowl established in s. NR 10.01 (1).


(1) WALWORTH COUNTY. (a) *Delavan Lake*. Township 2 north, range 16 east, town of Delavan.
