AN ORDER to repeal Ph-Int 1.03 (4) and 1.11; to amend Ph-Int 1.02 (6) and (7), 1.03 (2) (a), (b) and (f) and 1.04 (3); to repeal and recreate Ph-Int 1.03 (2) (g) and 1.06 (4); and to create Ph-Int 1.03 (2) (h), relating to internship credit hours.

## Analysis Prepared by the State of Wisconsin Pharmacy Internship Board

Prior to registration as pharmacist, a person must complete internship under the supervision of a practicing pharmacist certified by the pharmacy internship board. The board is also responsible for licensing interns.

The proposed changes affect the intern license fee and the duration of that license. Currently the license fee of \$10.00 and the license is valid until May 31 of the year succeeding the year of issuance. In effect, it amounts to an annual fee, subject to renewal for 2 or 4 years. Under the proposal, a one time license fee of \$50.00 would provide a license which would expire on July 1 in the fourth year succeeding the year of issuance.

The proposed changes affect the maximum amount of internship concurrent with academic registration in a Doctor of Pharmacy program. Currently a maximum of 500 hours of internship credit can be granted to students enrolled in either a Bachelor of Science degree in pharmacy or Doctor of Pharmacy degree program. This change would remove the 500 hour maximum for persons enrolled in Doctor of Pharmacy degree programs.

An additional change would apply the preceptor and site standards to school sponsored experiential course work for which internship credit is granted. Currently there is a waiver for preceptors and sites in a school sponsored experiential program.

The proposed changes would allow up to 300 hours of internship credit for less than full-time experiences concurrent with the academic registration in a Doctor of Pharmacy degree program and delete the qualifications in the current code for less than full-time experiences.

The proposed changes would repeal the requirement for interns to participate in a pre and post internship testing program.

The proposed changes would allow a registered pharmacist practicing outside a licensed pharmacy to be certified as a preceptor.

The proposed changes would require that a preceptor have at least 6 months practice experience at the internship site prior to placement of an intern with that preceptor.

The proposed changes would repeal the preceptor requirement of membership in a professional organization.

The proposed changes would repeal the waiver of the continuing education requirement for a preceptor who participates and successfully completes a written challenge examination.

The proposed changes repeal the transition rule in effect in 1991, Ph-Int 1.11.

Pursuant to authority vested in the state of Wisconsin pharmacy internship board by s. 36.25(20), Stats., the state of Wisconsin pharmacy internship board hereby proposes to amend, repeal and create rules interpreting ss. 36.25(20) and 450.045, Stats., as follows:

SECTION 1. Ph-Int 1.02 (6) and (7) are amended to read:

Ph-Int 1.02(6) The internship application is to be accompanied by a registration fee of \$10.00 \$50.00.

Ph-Int 1.02(7) Registration as an intern expires on May 31 July 1 in the fourth year succeeding the year in which the registration fee was recorded, unless revoked, suspended, or cancelled.

SECTION 2. Ph-Int 1.03(2)(a),(b) and (f) are amended to read:

Ph-Int 1.03(2)(a) No more than 1000 hours of internship credit shall be granted for periods of internship training completed prior to successful completion of all academic requirements for a Bachelor of Science degree in Pharmacy. (B.S. Pharmacy): or an entry level Doctor of Pharmacy (Pharm.D.) degree;

Not less than 500 hours of internship-for-credit shall be Ph-Int 1.03(2)(b) completed after successful completion of all academic requirements for a Bachelor of Science degree in pharmacy (B.S. Pharmacy) or entry level Doctor of Pharmacy (Pharm.D.)

degree at an institution recognized by the pharmacy examining

board:

Credit may be allowed under par. (a) for successful completion Ph-Int 1.03(2)(f) of a professional experience program sponsored by a professional Bachelor of Science degree in pharmacy or Doctor of Pharmacy degree granting institution. Credit shall be granted only where the program related to the responsibilities of a licensed pharmacist and the individual course meets preceptor, site and course content criteria established by the pharmacy

internship board;

SECTION 3. Ph-Int 1.03(2)(g) is repealed and recreated to read:

No more than 300 hours of internship credit, in aggregate, shall Ph-Int 1.03(2)(g)be granted for less than full-time internship training concurrent with academic registration in a Doctor of Pharmacy degree

program.

SECTION 4. Ph-Int 1.03(2)(h) is created to read:

> Internship credit exceeding 500 hours maybe granted for full-Ph-Int 1.03(2)(h) time internship training concurrent with academic registration in

the Doctor of Pharmacy degree program at the discretion of the

pharmacy internship board.

Ph-Int 1.03(4) is repealed. SECTION 5.

Ph-Int 1.04(3) is amended to read: SECTION 6.

> Ph-Int 1.04(3) All internship-for-credit shall be under the supervision of a preceptor who is certified by the pharmacy internship board. except for internship served as part of a professional experience program sponsored by a professional Bachelor of Science or Doctor of Science or Doctor of pharmacy degree granting institution.

## SECTION 7. Ph-Int 1.06 (4) is repealed and recreated to read:

Ph-Int 1.06 (4) An applicant for certification as a preceptor shall meet the following:

- (a) Completion of 36 months of practice as a registered pharmacist.
- (b) Completion of 6 months of practice at the internship site; a waiver may be granted if the applicant is transferred to a site within the same institution or company and is subject to the same operational policies and procedures.
- (c) Current full-time practice as a registered pharmacist.
- (d) Participation in continuing education and professional activities accredited by the pharmacy internship board, with the applicant accumulating a minimum total of 20 units in the 24 months preceding certification as a preceptor.
- (e) Participation in a preceptor conference at least once every 2 years. Credit for participation will be granted toward the continuing education and professional activities requirement as directed in par. (d).
- (f) A history of exemplary professional and personal conduct.

SECTION 8. Ph-Int 1.11 is repealed.

This rule shall take effect on January 1, 1996 as provided in s.227.22(2) (intro.), Stats.

It has come to my attention that in the recent revision of the administrative code of the Pharmacy Internship Board (Register, November, 1995, No. 479), there is an error with the regard to a reference in subsection Ph-Int 1.03(2)(d).

Currently it reads: Except as provided under par.(g), not more than 500 hours of internship-for-credit may be concurrent with academic registration.

It should read: Except as provided under phar.(h), not more than 500 hours of internship-for-credit may be concurrent with academic registration.

With the re-numbering and re-lettering that was part of the code revision, I missed this one.
