1. Membership. The Governor's Pardon Advisory Board shall consist of no more than seven members who serve a term of one year at the pleasure of the Governor.
  - (a) One member shall be appointed by the Governor to represent the Attorney General.
  - (b) One member shall be appointed by the Governor to represent the Secretary of the Department of Corrections.

(c) The Governor's Legal Counsel or his/her designee shall be a voting member and shall chair the board.

2. Functions and Operations. The Board shall review applications for executive clemency and make recommendations to the Governor as to each.

(a) Hearings

(1) The Board shall hold a public hearing on each qualifying application at which hearing the applicant shall be heard.

(2) Hearings shall be held subject to the discretion of the chair, at a date and place set at least two weeks in advance of the hearing.

(b) Recommendations to the Governor

(1) After a hearing is concluded, the Board shall meet in closed executive session, as permitted by Wisconsin Stats. s. 19.85 (1) (a), to arrive at a recommendation on the application. Four members constitute a quorum for executive action by the board.

(2) The factors the Board shall weight in its decision include, but are not limited to, the severity of the offense, the time passed since discharge or conviction, the applicant's need for clemency and the applicant's activities and conduct since the offense.

(3) The chair shall convey to the Governor in writing the Board's recommendation for each application, along with dissenting recommendations, if any, and reasons given for each.

3. Manner and Form of Applications

(a) Scope

(1) These rules shall govern all applications for any form of clemency by any person except individuals currently incarcerated.

(2) All applications for any form of clemency to which these rules do not apply shall be governed by Wisconsin Statutes Sections 304.08 through 304.11.

(b) Form and Contents

(1) Applications for any form of clemency shall be in writing, signed by the person seeking clemency, notarized by a notary public and submitted to the Governor.

(2) Applications shall contain the following information:

- a. the name of the applicant
- b. the applicant's current address and mailing address if different
- c. the applicant's date of birth
- d. the exact form of clemency sought
- e. the conviction(s) from which relief is sought
- f. the court that imposed sentence (county and branch)
- g. the date of sentencing
- h. the sentence imposed
- i. the place of incarceration (if applicable)
- j. a description, in the applicant's own words, of the circumstances of the crime
- k. a statement of any facts which the applicant believes justify clemency, including activities since conviction, employment history and information pertaining to the applicant's need for clemency
- L. subsequent contacts with law enforcement
- m. whether the applicant has applied for clemency in the past and what date the application was decided by the Governor

(3) The Governor, through the office of Legal Counsel, may set other conditions, requirements and procedures in relation to the application process, including but not limited to, prerequisites and conditions for applying for clemency.

- (c) Service of Notice
  - (1) The applicant shall serve on the judge of the court of conviction and on the district attorney of the county of conviction, a notice of application which shall contain the information required in the application by s. 3. (b) of this order.
  - (2) Service of notice may be by mail, but the Governor's Office must be given proof of service by providing a copy of the notice as signed or stamped by the person upon whom notice was served.
- (d) Court Records
  - (1) The applicant shall obtain and provide to the Governor's Office certified copies of the following court records for all convictions for which the person is seeking clemency:
    - a. The indictment, information or complaint; and
    - b. The judgment of conviction and sentencing
  - (2) If copies of any of the required court records are unavailable, the applicant shall submit to the Governor's Office a letter from the clerk of courts of the county of conviction stating that copies are unavailable.
- (e) An application shall be complete when it contains the information and documents required by subsections (a), (b), and (c) of this section.

WHEREAS, Wisconsin will be among the sixth group of five states which coins will commemorate, for release in 2004; and

WHEREAS, under the Act, the Governor of the State of Wisconsin is responsible for establishing a selection process and submitting coin concepts which are emblematic of the State of Wisconsin to the Citizens Commemorative Coin Advisory Committee and the Fine Arts Commission of the United States for consideration, with final approval by the Secretary of the Treasury;

NOW, THEREFORE, I, SCOTT McCALLUM, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and laws of this state, and specifically by Section 14.019 of the Wisconsin Statutes, do hereby declare and order that:

- 1. Wisconsin residents are hereby encouraged to submit design concepts for consideration.
- 2. A Wisconsin Commemorative Quarter Council is hereby created and assigned the responsibility for submitting coin concepts to the Governor.
- 3. The members of the Wisconsin Commemorative Quarter Council shall be appointed by the Governor to serve at the pleasure of the Governor. The Council shall consist of the Governor or his designee, the Secretary of the Department

- of Financial Institutions or his designee, the Director of the State Historical Society or his designee, a teacher, a student, a numismatic, an artist, three Wisconsin citizens at large and any additional members the Governor may so designate. The Governor shall designate one (1) member of the Council to serve as Chair and one (1) member to serve as its Vice-Chair.
- 4. The Wisconsin Commemorative Quarter Council shall solicit and receive coin concepts from Wisconsin Citizens for consideration.
- 5. The Wisconsin Commemorative Quarter Council shall review such coin design concepts and recommend five concepts to the Governor. During this process, the panel shall:
  - (a) Give highest consideration to concepts which promote Wisconsin's rich heritage and recognize Wisconsin's historical significance; and
  - (b) Abide by the federal design concept standards provided in the Act, which are outlined in Attachment A to this Order; and
  - (c) Abide by the state design concept standards provided for in the Act, which are outlined in Attachment B to this Order; and
  - (d) Meet no later than January 2002 to review the coin design concepts submitted to it; and
  - (e) Create advisory committees as it deems necessary and consult with Wisconsin Historians, art and design experts, coin experts, and residents in its review of the coin design concepts; and
  - (f) Recommend five coin design concepts to the Governor no later than April 2002.

- 6. Direct the Department of Administration to provide the Task Force with such sums of money as are necessary for travel and operating expenses in accordance with Section 20.505 (3) (a) of the Wisconsin Statutes; and
- 7. Provide that the Task Force shall dissolve when its final report is accepted by the Governor;

**EXECUTIVE ORDER 31.** An Amendment Relating to the Governor’s Task Force on Terrorism Preparedness.

**EXECUTIVE ORDER 32.** Relating to the Creation of the Governor’s Commission on Historic Sites.

WHEREAS, the Wisconsin Historical Society’s ten historic sites are important to the interpretation of our heritage for the citizens of Wisconsin; and

WHEREAS, Wisconsin’s historic sites are an important component of our state’s tourism industry and the schools’ state history programs; and

WHEREAS, Wisconsin’s historic sites have experienced declining attendance during the past five years and difficulties in retaining seasonal staff and caring for their large and important collections of artifacts; and

WHEREAS, Wisconsin is committed to maintaining a high-quality, economically variable system of state historic sites;

NOW, THEREFORE, I, SCOTT McCALLUM, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and laws of this state, and specifically by Section 14.019 of the Wisconsin Statutes, do hereby:

1. Create the Governor’s Commission on Historic Sites (“Commission”); and
2. Provide that the Commission shall consist of not more than eleven (11) members appointed by the Governor to serve at the pleasure of the Governor; and
3. Provide that the Governor shall designate one (1) member on the Commission as chair to serve in this capacity at the pleasure of the Governor; and
4. Provide that the Commission shall have the following mission:
  - (a) Report on the current state of the Society’s historic sites; and
  - (b) Access economic operating models used by the sites; and
  - (c) Assess models of interpretation used by the sites; and
  - (d) Assess current promotional activities for the Society’s historic sites; and
  - (e) Assess the sites’ stewardship of collections, which include historic buildings, major museum collections, and archives; and
5. Require the Commission to prepare and submit a report to the Governor detailing its findings and proposing recommendations for the operation of the Society’s historic sites while not increasing current state funding levels; and
6. Require the Commission to submit periodic reports to the Governor as the chair deems necessary and a final report to the Governor no later than July 1, 2002; and
7. Direct the Wisconsin Historical Society to provide the Commission with administrative and support services; and
8. Direct the Department of Administration to provide the Commission with such sums of money as are necessary for travel and operating expenses in accordance with Section 20.505 (3) (a) of the Wisconsin Statutes; and
9. Provide that the Commission shall dissolve when its final report is accepted by the Governor.

**EXECUTIVE ORDER 34.** Relating to the Creation of the Governor’s Year of the Trails Commission.

WHEREAS, Wisconsin’s trail system has more than 1,400 miles of trails which provide outdoor enjoyment and recreation to thousands of users; and

WHEREAS, Wisconsin’s trails offer a variety of activities including all-terrain vehicle riding, bicycling, cross-country skiing, disabled access, dog sledding, hiking, horseback riding, kayaking, rollerblading, snowmobiling, snowshoeing and walking; and

WHEREAS, Wisconsin’s trails provide health benefits to its users, help preserve the environment, boost local economies, generate community pride and improve the quality of life for residents; and

WHEREAS, Wisconsin is committed to informing and educating others on the benefits of the trail system;

NOW, THEREFORE, I, SCOTT McCALLUM, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and laws of this state, and specifically by Section 14.019 of the Wisconsin Statutes, do hereby:

1. Create the Governor’s Year of the Trails Commission (“Commission”); and
2. Provide that the Commission shall consist of not more than twenty-one (21) members appointed by the Governor to serve at the pleasure of the Governor; and
3. The Governor shall designate one (1) member of the Commission to serve as Chair and one (1) member to serve as Vice-Chair.
4. Provide that the Commission shall prepare a plan for the Year of the Trails by:
  - (a) promoting of the economic, environmental and social benefits of the trails including community-building opportunities; and
  - (b) promoting of the health benefits of the trails; and
  - (c) promoting of the use of trails as an alternative means of transportation; and
  - (d) encouraging more people to use trails; and
  - (e) increasing awareness of the importance of trails and the need to maintain them; and
  - (f) raising the visibility of the trails.
5. Require the Commission to prepare and submit periodic reports to the Governor with recommendations for the Year of the Trails; and
6. Require the Commission to submit a final report to the Governor no later than January 2003; and
7. Direct the Department of Natural Resources’ Bureau of Parks and Recreation to provide the Commission with administrative and support services; and
8. Direct the Department of Administration to provide the Commission with such sums of money as are necessary for travel and operating expenses in accordance with Section 20.505 (3) (a) of the Wisconsin Statutes; and

Provide that the Commission shall dissolve when its final report is accepted by the Governor.

WHEREAS, holding probation and parole violators accountable for their disruptive behavior enhances the safety of communities throughout Wisconsin; and

WHEREAS, through a cooperative effort, Wisconsin Sheriffs, the Department of Correction and the residents of Wisconsin can realize the benefits of more efficiency in conducting community corrections;

NOW, THEREFORE, I, SCOTT McCALLUM, Governor of the State of Wisconsin by the authority vested in me by the Constitution and the laws of this State, and specifically by Section 14.019 of the Wisconsin Statutes, do hereby:

1. Create the Governor's Task Force on Jails and Community Corrections (hereinafter "Task Force") and shall consist of twelve (12) members appointed by the Governor to serve at the pleasure of the Governor; and
2. Provide that the Governor shall designate one (1) member of the Task Force as chair to serve in that capacity at the pleasure of the Governor; and
3. Provide that the Task Force shall have the following mission:
  - a. Study the current policies and procedures related to probation and parole holds; and
  - b. Seek means of efficiency in community corrections for Wisconsin Counties and the Wisconsin Department of Correction; and
  - c. Generate solutions and the necessary means of implementation;
4. Require the Task Force to draft a final report due to the Governor by January 10, 2003; and
5. Direct the Department of Administration to provide the Task Force with such sums of money as are necessary for travel and operating expenses in accordance with Section 20.505 (3) (a) of the Wisconsin Statutes; and
6. Provide that the Task Force shall dissolve when its final report is accepted by the Governor;

**EXECUTIVE ORDER 39.** Relating to the Creation of the Governor's Task Force on Small Business Regulatory Reform.

WHEREAS, small business is Wisconsin's largest employer and greatest generator of jobs; and

WHEREAS, Wisconsin's 100,000 small businesses are a key sector of Wisconsin's economy, providing more than 1.2 million jobs and \$21 billion in payroll income; and

WHEREAS, 96 percent of Wisconsin businesses employ fewer than 100 employees; and

WHEREAS, regulations can be disproportionately burdensome to small businesses which have limited resources to meet the high costs of compliance in comparison to larger businesses;

NOW, THEREFORE, I, SCOTT McCALLUM, Governor of the State of Wisconsin by the authority vested in me by the Constitution and the laws of this State, and specifically by Section 14.019 of the Wisconsin Statutes, do hereby:

1. Create the Governor's Task Force on Small Business Regulatory Reform (hereinafter "Task Force") consisting of twelve (12) members appointed by the Governor to serve at the pleasure of the Governor; and
2. Provide that the Governor shall designate two (2) members of the Task Force as Co-chairs to serve at the pleasure of the Governor; and
3. Provide that the Task Force shall have the following mission:
  - a. Examine the existing statutory provisions, administrative rules and other state policies related to the regulatory process and recommend actions or legislative changes needed to ensure efficient and cost effective regulations; and
  - b. Assure smaller businesses achieve regulatory compliance without unnecessary expense or inconvenience; and
  - c. Review ways to reduce the negative impact of state rules and regulations on small businesses; and
4. Require state agencies to analyze the impact of their regulatory actions on small entities and determine if a rule will have a significant economic impact on a substantial level of small businesses; and
5. Direct the Department of Commerce to provide staff support to the Task Force; and
6. Direct the Department of Administration to provide the Task Force with such sums of money as are necessary for travel and operating expenses in accordance with Section 20.505 (3) (a) of the Wisconsin Statutes; and
7. Provide that the Task Force issue a report to the Governor within one year of the first meeting date; and
8. Provide that the Task Force shall dissolve when its final report is accepted by the Governor.
