**Initial Regulatory Flexibility Analysis:** The proposed rule will have an effect on small businesses, as defined under s. 227.114 (1), Stats. The projected costs are \$300 per user per year (Individual Yearly Rate); \$300 per user per year for the first 5 users in the organization plus \$150 per user per year thereafter (Organizational Yearly Rate); and \$50 per user per month (Individual Monthly Rate). For even a very small business, such as a self-employed individual, these costs are not a significant economic impact. If the Department did not support the Active Surveying Reference Station System, it would either no longer function or be replaced by a privately-run surveying reference system. Either alternative would be much costlier to providers of surveying services than the current system.
