The Department of Natural Resources announces that it will hold a public hearing on a permanent rule to revise ch. NR 10, relating to the eliminating night hunting restrictions for raccoons, at the time and place shown below.

**Rule Information:** This rule removes the restrictions for night hunting of raccoons, coyotes and fox during the nine-day deer gun season in the forest and central farmland deer management zones.
