Wisconsin's Statewide Transit Planning ("Section 5304") Program supports local and regional transit planning efforts by offering funding for relevant studies and plans. Funding is available at up to 80 percent of eligible expenses. Eligible applicants include Metropolitan Planning Organizations (MPOs), local government authorities, and operators of public transportation systems.

The Wisconsin Department of Transportation (WisDOT) accepts planning grant applications at any time via our [BlackCat grants management website](#), and reviews applications in the order received. However, we review applications and issue awards on a bi-annual basis. Awards are issued on or about each January 15 and July 15. To receive consideration for a January 15 award, an agency must apply by December 31. To receive consideration for a July 15 award, an agency must apply by June 30.

Typically, Federal Transit Association (FTA) funds are not immediately available, so WisDOT will issue pre-award spending authorization in conjunction with an award. This allows the grantee to incur reimbursable expenses while WisDOT awaits FTA funding.
